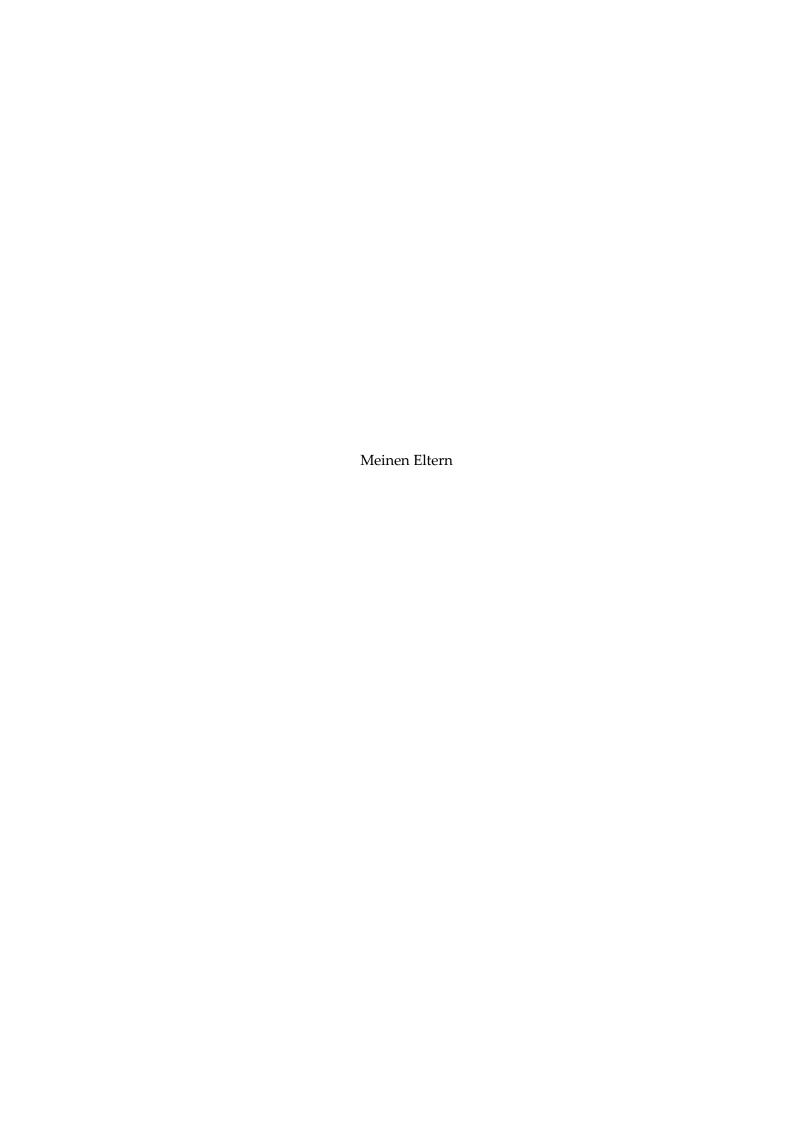

#### **CHAPTER 1**

#### Introduction

The impact of human activity on the environment has always been a central part of scientific research. Environmental protection has gained social and political importance in recent decades due to anthropogenic influences on climate, on water sources and on soils. Agriculture, especially animal husbandry, is often criticised for high nitrogen (N) emissions (i.e., ammonia, nitrate, and nitrous oxide) to the environment. Excess N which is not retained in animal tissues or animal products (e.g., milk) is excreted in urine and faeces contributing to environmental pollution (Hristov et al., 2019; Hristov et al., 2011). In dairy cattle production, increasing N use efficiency (i.e., proportion of milk N yield of total N intake) has become of growing interest for some time, in order to reduce N excretion and associated negative ecological impacts, and to reduce feeding costs. In addition to the knowledge of cows' nutrient requirement, a precise determination of feed protein value is a key prerequisite to maintain performance-adapted and nutrient-efficient feeding. In contrast to monogastric livestock, the ruminant digestive system is characterised by pregastric fermentation through symbiotic microorganisms (van Soest, 1994). This means, that feed consumed by the animal is first subjected to microbial degradation in the forestomachs. The symbiosis enables the host animal to utilize structural carbohydrates (cellulose, hemicelluloses, pectins) as an energy source, which could otherwise not be utilised. The end products of carbohydrate degradation are primarily volatile fatty acids (VFA; acetate, propionate, butyrate), which are absorbed via the rumen wall and are thus available to the animal's metabolism. Moreover, there is a significant protein or N turnover in the forestomachs, which can be divided into two distinct events occurring simultaneously: crude protein (CP; N x 6.25) degradation and microbial crude protein (MCP) synthesis (Bach et al., 2005). Degradable CP is largely hydrolysed to amino acids (AA) and almost completely deaminated by proteolytic activity of microorganisms, mainly resulting in ammonia (NH<sub>3</sub>) (Simon, 2020). Rumen-undegradable CP (RUCP) escapes fermentation and enters the duodenum undegraded. Microbial protein synthesis greatly depends on rumen available energy, which is mainly derived from fermentation of structural and non-structural carbohydrates, yielding VFA, and the process in turn produce microbial cells by incorporating AA and non-protein N (NPN) compounds (Ørskov, 1992). Ruminal fermentation occurs under continuous-culture conditions,

whereby continual microbial growth is maintained by ongoing nutrient supply and removal of fermentation end products and microbial biomass (Edwards *et al.*, 2008).

Fermentation in the forestomachs poses a challenge in feed evaluation, because concentration and composition of feed CP provide little information about the protein supply to the animal (Steingaß and Südekum, 2013). Enzymatic digestion of protein and absorption of AA by the animal take place in the small intestine, consequently, feed protein value is evaluated at an intestinal level. For this purpose, protein evaluation systems are used, which were normally based on either empirical or mechanistic models. In Germany, the determination of protein value is currently based on empirical equations derived from in vivo measurements on duodenal fistulated cows, including the variables metabolisable energy (ME) or digestible organic matter (DOM), CP and RUCP (GfE, 2001; Lebzien et al., 1996). These equations account for the dependence of MCP yield on the supply of energy to the microbes, but it is not possible to consider other influencing factors. To account for additional influencing factors such as type of substrate fermented, ruminal microbiota or (fractional) degradation and passage rate of feed particles, mechanistic models are needed. In contrast to models based on experimental data, mechanistic models are much more complex, but might lead to a better estimation of the protein value (Dijkstra et al., 2005; Dijkstra et al., 1998). However, the high number of factors included therein might limit their routine use in feed evaluation (Krieg, 2017). Even if nomenclature, exact definitions, methods, and assumptions differ between protein evaluation systems, most of them are based on an estimation of RUCP and MCP supply. Herein, RUCP contents are commonly derived from in situ measurements, whereas MCP is predicted assuming a fixed (or variable) yield of MCP synthesised per unit of, for instance, fermentable organic matter (**FOM**), DOM or ME (GfE, 2001; Lebzien et al., 1996), depending on the evaluation system.

The *in situ* technique is an internationally accepted method to determine ruminal CP degradation of feeds. It is based on an incubation of feed samples placed in polyester bags and incubated in the rumen of cannulated animals for various lengths of time. Despite its wide application, however, this method cannot be considered as an absolute reference, because there are some methodological limitations of varying importance depending on the feed material examined (Lebzien and Flachowsky, 2005; Michalet-Doreau and Ould-Bah, 1992; Ørskov *et al.*, 1980). Ruminant feeds vary widely in terms of their ruminal CP degradation (Universität Hohenheim - Dokumentationsstelle, 1997) and can roughly be divided into feeds with high (75-95%), medium (65-85%) and low (55-75%) degradability (GfE, 1986). Easily

degradable are e.g., CP from fresh or ensiled grass, whereas CP e.g., from soybean or rapeseed meal have low intraruminal degradability. Besides digestible CP, RUCP also contains some completely indigestible parts (Huhtanen, 2005). In the past, extensive research focussed on enhancing RUCP in feeds aiming on higher protein supply to the animal and subsequently increased performance. Physical or chemical feed treatments have been successfully applied to enhance RUCP content (van der Poel et al., 2005). However, enhancing RUCP concentration in feed is not generally reflected in a milk production response as observed in meta-analyses (Ipharraguerre and Clark, 2005; Santos et al., 1998). This can have several causes. For example, there is evidence that treated feeds could have reduced digestibility especially through heat damage (van Soest, 1994) and that RUCP supplements can have a negative impact on MCP synthesis (Ipharraguerre and Clark, 2005; Santos et al., 1998). Presumably, in the past, RUCP was given a disproportionately high importance in the protein supply of the animals (Huhtanen and Hristov, 2009; Ipharraguerre and Clark, 2005; Santos et al., 1998). Nevertheless, because of limited feed or energy intake capacity and the resulting limited MCP yield, RUCP supply to the animals, as well as its AA composition becomes more important with increasing milk yield (Flachowsky and Lebzien, 2006).

The MCP yield is derived from variables that reflect the amount of FOM. Besides the quantitative supply of FOM, microbial growth is influenced by a variety of factors such as FOM composition (van Duinkerken et al., 2011) and rumen available N sources (Dijkstra et al., 2013). Moreover, synchronous energy and N release in the rumen is important, as the potential of energy-dependent MCP synthesis is limited if there is a lack of N in the rumen (Huhtanen, 2005). In the case of N surplus relative to the microbial need, excess N is absorbed as NH3 via the rumen wall, converted to urea in the liver and either excreted in urine or recycled (rumino-hepatic cycle). Recycling means that urea is returned into the rumen via saliva or diffusion through the rumen wall to be reused for the MCP synthesis (Simon, 2020). The ruminal N balance (RNB) characterizes the feed according to the ratio between the amount of N and energy available in the rumen. A positive RNB indicates, that there is more N available than can be used by the microorganisms. A negative RNB, on the other hand, describes an N deficiency for the microbes. Negative RNB can be balanced to some extent via the rumino-hepatic cycle (Hristov et al., 2019), but strongly negative values can decrease dry matter intake, MCP synthesis, and milk yield as reviewed by Flachowsky and Lebzien (2006).

Outflow of MCP from the rumen significantly contributes to the protein supply to the cows by having a relatively constant AA ratio with high intestinal digestibility (Ørskov, 1992). In addition, MCP contains all essential AA in sufficient amounts, which means that the animals' AA requirements can also be met exclusively from NPN compounds (Ørskov, 1992; Steingaß and Südekum, 2013). However, only one fourth to one third of feed-N is transferred into milk i.e., N use efficiency averaged at 25-28% in lactating dairy cows as reported in a meta-analysis of large datasets of North American (736 diets) and North European (998 diets) milk production trials (Huhtanen and Hristov, 2009). This (seemingly) low N efficiency is caused, among other factors, by MCP contribution to the protein supply to the cows, because non-NH<sub>3</sub>-N content in duodenal chyme contain about 27% non-AA-N (GfE, 2001), whereof a large part are nucleic acids from microbial origin. However, this should in no way diminish the benefits gained through fermentation.

Degradation of CP and RUCP content are analytically sufficiently represented by chemical methods or enzymatic approaches (Licitra *et al.*, 1998; Sniffen *et al.*, 1992) and their use is superior to the *in situ* technique in terms of effort, costs, and reproducibility. However, MCP yield can only be reliably represented by biological systems. The modified Hohenheim gas test (**modHGT**) offers a simple method for the combined determination of RUCP and MCP. This method is based on an incubation of feed samples in rumen-fluid buffer solution. Thus, possible interactions between CP degradation and MCP yield and other factors influencing MCP growth can be considered.

The sum of RUCP and MCP is referred to as utilisable CP at the duodenum (**uCP**) and used to describe the protein value of feeds and the requirement of dairy cows in the German protein evaluation system (GfE, 2001). But, as noted by Westreicher-Kristen *et al.* (2015) the term "utilisable" may lead to misunderstandings, as it describes the quantity of CP found at the duodenum, rather than the available quantity of CP to the metabolism. For this reason, the term post-rumen CP (**prCP**) is used instead of uCP within the present thesis. Post-rumen CP can be converted to the more common international value, metabolisable protein (**MP**), which is the total amount of digestible true protein (AA) available to the animal for metabolism (AFRC, 1993; NRC, 2001). The actual supply of AA to the animal depends on a variety of factors such as AA composition and AA absorption from prCP in the small intestine as well as utilization of absorbed AA for protein synthesis (Flachowsky and Lebzien, 2006). An assessment of these variables could not be made within the scope of this work.

#### **Objectives of the thesis**

An adequate protein supply to dairy cows is of central importance for ecological, economic, and animal welfare reasons. However, a direct measurement of the protein value of feeds or feed mixtures through routine application of *in vivo* investigations is not conceivable. Rather, protein value has to be estimated using protein evaluation systems based on empirical or mechanistic models. However, empirical equations are derived from experimental data, thus their applicability is restricted to the conditions during data collection (Dijkstra *et al.*, 2005). Mechanistic models are applicable to a broader range of data, but they are much more complex through consideration of a high number of factors which might limit their routine use in feed evaluation (Dijkstra *et al.*, 2005; Krieg, 2017). Furthermore, the basic principle of most evaluation systems are estimates of RUCP and MCP, but both estimations are subjected to various assumptions and different limitations. A reliable method suitable for routine testing is therefore imperative.

The overall aim of this work was to show the potential of the modHGT for the assessment of protein value of feeds for ruminants. For this purpose, two studies were conducted, within both of each, *in vitro* determined prCP values were compared to those obtained *in situ*. *In situ* values were calculated as the sum of RUCP and MCP, where a constant value of 181 g MCP/ kg FOM was used to estimate MCP yield (Lebzien and Voigt, 1999). In turn, FOM was derived from effective OM degradation determined *in situ*.

**Study 1** (**Chapter 2**): Effect of wilting and lactic acid bacteria inoculant on in situ and in vitro determined protein value of grass silages.

In addition to the method comparison, the aim of the first study was also to investigate the effect of pre-ensiling treatments on RUCP and prCP content in grass silages. Therefore, grass silages were wilted to 8 different DM concentrations and ensiled with or without the use of lactic acid bacteria inoculum.

**Study 2** (**Chapter 3**): In situ and in vitro determination of the protein value of feeds for ruminants.

In the second study, 9 feeds, 13 feed mixtures made thereof, and 12 feed mixtures provided by commercial dairy farms were examined, covering a broad range of feed components and chemical ingredients.

# Effect of wilting and lactic acid bacteria inoculant on *in situ* and *in vitro* determined protein value of grass silages.<sup>1</sup>

#### 2.1 Abstract

The objective of this study was to evaluate the effect of dry matter (DM) concentration and the use of lactic acid bacteria (LAB) inoculant on the protein value of grass silages. Grass samples containing 170 g DM/kg fresh material were wilted to different DM concentrations (310, 390, 420, 470, 530, 580, 600 g/kg fresh material) before ensiling. Half of the grass material at respective DM was treated with LAB, the other half remained untreated (control, CON). Ruminal degradation of organic matter (OM) and crude protein (CP) was determined using the *in situ* technique. For this, silage samples were incubated for 2, 4, 8, 16, 24, 48 and 72 h. Rumen undegraded CP (**RUCP**) was derived from *in situ* CP degradation. Microbial CP (**MCP**) synthesis was assumed to be 181 g per kg fermented OM. Post-ruminal CP (prCP) was defined as the sum of RUCP and MCP. Effective prCP in situ was calculated for passage rates (k) of 0.02, 0.04 and 0.06/h. In addition, the modified Hohenheim gas test (**modHGT**) was used to determine effective prCP *in vitro* for the same passage rates. The DM linearly increased effective prCP in situ in CON (P<0.001) and LAB (P<0.001). This was caused by both increased RUCP in the range of 580–600 g DM (*P*<0.001) and increased MCP (*P*<0.001) due to higher amount of water-soluble carbohydrates in the more intensively wilted silages. The use of LAB increased RUCP (P<0.001) but decreased the calculated MCP content (P<0.001). Therefore, these effects compensated each other leading to only slightly lower effective prCP in situ for LAB (*P*<0.05). The positive effect of DM on effective prCP *in situ* was confirmed in vitro (P<0.001) showing no effect of the inoculant. Based on both methods effective prCP increased to a small extent with 2.3 to 4.9 g/kg OM (P<0.001), when DM increases by 100 g/kg fresh material, depending on the assumed passage rate. Therefore, wilting and LAB addition to grass have the potential to improve protein value of grass silage. Both methods delivered similar estimates for effective prCP. But modHGT appeared to be superior to the *in situ* technique by being more sensitive, not requiring separate estimation of MCP and the assumption of a certain efficiency value, and by having lower operating expenses. The results of this study show the potential of the modHGT, however further studies are required to standardize and validate this technique and to evaluate the effect of wilting grass on animal performance.

#### 2.2 Introduction

A precise determination of the protein value of feeds is crucial to meet the protein requirements in high yielding dairy cows, where both protein excess and protein deficit should be avoided for economic, environmental, and animal welfare reasons. The decisive factor here is the amount of post-rumen crude protein (prCP), which is referred to as utilisable crude protein at the duodenum (**uCP**, **nXP** in German) in the German protein evaluation system (GfE, 2001). It corresponds to the sum of microbial crude protein (MCP) synthesized in the rumen and rumen undegraded crude protein (**RUCP**), where MCP is quantitatively more important (Huhtanen, 2019; Tamminga, 1982). Due to the high proportion of grass silage in many diets, even a small enhancement of prCP in forages provides a significant contribution to meet the protein demand in ruminants. About 75% of crude protein (CP) in forage is degradable in the rumen (Merchen and Bourquin, 1994), of which 40-60% is present as non-protein nitrogen (NPN) in grass silages (Edmunds et al., 2012b). Because MCP synthesis is predominantly energy-dependent, a great proportion of ammonia is absorbed in the rumen and excreted via urine, if – as the case in many forages – rapidly fermentable carbohydrates are not sufficiently available (Flachowsky and Lebzien, 2006; Tamminga, 1982). Therefore, N utilization in forages can be improved by either promoting MCP synthesis or by increasing the proportion of RUCP and consequently reducing N excretion. Literature indicates that wilting enhances the amount of fermentable organic matter available for MCP synthesis and MCP outflow of the rumen (Johansen et al., 2017; Verbič et al., 1999). Pre-wilting of forage also reduced the proportion of NPN (Hartinger et al., 2019; Tamminga et al., 1991) which has a positive effect on RUCP content (Aufrère et al., 2003; Edmunds et al., 2014; Johansen and Weisbjerg, 2016). Furthermore, inoculants containing lactic acid bacteria (LAB) reduces proteolysis during ensiling (Slottner and Bertilsson, 2006) and increases RUCP content (Kramer, 2011).

Many studies are available which determined different feed treatments affecting CP degradation and RUCP content, but little information is available about these effects on the extent of organic matter (**OM**) degradation, the main determinant for MCP yield. Therefore, a one-sided view regarding RUCP alone does not allow any conclusions about effects on prCP content. The standard procedure used in many protein evaluation systems is the determination of RUCP by the *in situ* method, allowing the description of nutrient degradation over time, but it shows distinct limits in estimating prCP content. In previous studies, the modified Hohenheim gas test (**modHGT**; Steingaß and Südekum, 2013) has been shown to provide reliable

figures for prCP content. A decisive advantage of this *in vitro* method is the measurement of the total amount of prCP instead of a separate determination of RUCP and MCP. This evades the problem that RUCP and MCP are not independent measures which questions additivity of both components (GfE, 2001). The aims of this study were (1) to investigate the effect of dry matter (**DM**) concentration and the use of an inoculant containing LAB on RUCP and prCP content in grass silages and (2) to compare prCP content measured *in vitro* with those obtained *in situ*. We hypothesized, that (1) wilting and LAB improves the protein value of grass silages, (2) both methods reflect the treatment effects and (3) the less laborious modHGT provides reliable estimates for prCP content in grass silages and can be used as an alternative to the *in situ* method.

#### 2.3 Materials and methods

The studies reported here were performed in accordance with the German Animal Welfare Act (Federal Republic of Germany, 2014). *In situ* ruminal degradation experiment was performed at the Department of Animal Nutrition of the Hohenheim University, Stuttgart, Germany and was approved by the Regional Council Stuttgart of the Ministry of Rural Areas and Consumer Protection of the federal state Baden-Württemberg, Germany. *In vitro* incubation was carried out at the Institute of Animal Nutrition and Physiology of the Christian-Albrechts-Universität, Kiel, Germany, and the collection of rumen-fluid from fistulated heifers was approved by the Animal Welfare commission of the Ministry of Energy, Agriculture, Environment, and Rural Areas of the federal state of Schleswig-Holstein, Germany.

#### 2.3.1 Grass Silages

Perennial ryegrass (*Lolium perenne*, second cut 2017, 31 d of regrowth) cultivated at the Chamber of Agriculture of Schleswig-Holstein (Futterkamp, Germany) was used for the experiment. After cutting, grass was wilted using floor ventilation with heated air (~40 °C) to obtain eight different DM concentrations (achieved values were: 170, 310, 390, 420, 470, 530, 580 and 600 g DM/kg fresh matter), where 170 g DM refers to fresh grass without any artificial drying. The treatments were denoted according to their DM concentration before ensiling as following: DM-g/kg fresh material, e.g., DM-170.

Total processing time after cutting took about 2 and 60 h for the first and the last silage, respectively. Herein, the artificial drying procedure – interrupted overnight – lasted between 1 and 12 h to obtain materials with 310 to 600 g DM/kg.

During interruption grass material was stored in a stockroom under atmospheric air (~14 °C). After wilting, the grass material was chopped (20-30 mm) using a laboratory forage chopper (Hege, Waldenburg, Germany). Unwilted and wilted grass was ensiled without (control, **CON**) or with an inoculant (BonsilagePlus, Co. Schaumann, Germany; 1 g/t grass) containing a mixture of homo- and heterofermentative LAB. Subsequently, grass material was ensiled in quadruplicate in 1.5 L glass jars. Ensiled amount varied between 200 and 500 g DM per glass jar, depending on the DM concentration of the grass material. Glass jars were stored under controlled temperature of ~25 °C and lasted for 90 days. In total, 16 treatments were tested and are referred to the use of inoculant (without inoculant: CON, with inoculant: LAB) and to DM concentration (170, 310, 390, 420, 470, 530, 580, 600), e.g., LAB-170.

#### 2.3.2 Chemical analysis

Silage samples were analysed for DM, ether extract (EE), water-soluble carbohydrates (WSC), neutral detergent fibre (assayed with a heat stable amylase and expressed exclusive of residual ash, aNDFom) and acid detergent fibre (expressed exclusive of residual ash, ADFom) using near-infrared reflectance spectroscopy. Fermentation pattern (lactic acid, acetic acid, propionic acid, propane-1,2-diol, ethanol, n-butyric acid, n-propanol) were analysed by high performance liquid chromatography. Silage pH and NH<sub>3</sub>-N concentration were determined according to VDLUFA (2007; method 18.1) and VDLUFA (1995; method 3.2.6), respectively. These analyses were conducted by ISF Schaumann Forschung GmbH, Wahlstedt, Germany.

Silage samples used for *in situ* and *in vitro* incubations as well as the residues in the polyester bags after fermentation were analysed for oven-DM (without correction for volatile compounds), crude ash (CA), and CP according to the official analytical methods in Germany (methods 3.1, 8.1 and 4.1.1, respectively; VDLUFA, 2007). Prior to analysis, silage samples were freeze-dried, pooled within treatment, and ground to pass through a 1-mm screen (Ultra centrifugal mill ZM 200, Retsch GmbH, Haan, Germany).

#### 2.3.3 *In situ* procedure

Three ruminally cannulated and non-lactating Jersey-cows with an average body weight of 556 kg at the research station Meiereihof, Hohenheim University, Germany were used. The cows received hay and a mixed ration composed (in g/kg DM) of 350 maize silage, 350 grass silage, 250 hay, 30 barley straw and 20 of a mineral-vitamin mixture (including urea). Feed and water were offered for *ad libitum* 

consumption. Mean DM intake was 2 kg hay and 9 kg mixed ration/d. For the *in situ* incubations, grass silage was pooled per treatment, freeze-dried, and ground to pass through a 2-mm sieve using a rotor mill (Brabender GmbH, Duisburg, Germany). Approximately 1.4 g on DM basis of each sample was placed into polyester bags (5 × 10 cm, 50 μm pore size, 14 mg DM sample/cm<sup>2</sup> polyester bag; ANKOM Technology Macedon, NY, USA). Bags were closed tightly with cable ties and fixed to an anchor weight. Prior to incubation, bags were soaked in warm tap water (~39 °C) for 5 min. Bags were introduced into the rumen immediately after morning feeding in the ventral sac. Four bags per treatment and time point (analytical replicates) were incubated in each cow (statistical replicates). After 2, 4, 8, 16, 24, 48 and 72 h polyester bags were removed from the rumen, immediately immersed into ice-cold water to minimize microbial activity, and rinsed in cold tap water to remove excess ruminal content. Additionally, four polyester bags per treatment and animal without incubation were used for determination of zero time (0 h) disappearance, the washout fraction at time point 0 h. All bags (including the 0 h) were washed together with cold water for 15 min in a washing machine (type WM14A160; Siemens GmbH, Munich, Germany) without centrifugation. Afterwards, bags were dried at 60 °C in an air forced oven for 24 h, weighted and stored until analysis. Two bags per treatment, time point, and cow were used for determining OM and CP degradation each.

Water-soluble (**WS**) fraction was estimated in quadruplicate by mixing samples (1 g fresh matter) in 50 ml warm water (37 °C) for 1 min before washed through a folded filter paper (No. 615 1/4, Ø: 150 mm, Macherey-Nagel, Düren, Germany). Water-insoluble fraction escaping as small particles (**SP**) from the polyester bags was estimated by subtracting WS fraction from 0 h washout fraction. The single values obtained for OM and CP disappearance (DI) were corrected (C) for loss of SP according to Hvelplund and Weisbjerg (2000) at each incubation time point as:

where CDI, DI, SP and WS are given as fraction (g/g) of OM or CP, respectively.

The CDI of CP was corrected afterwards for microbial attachment (**MA**) according to Krawielitzki *et al.* (2006) as:

where MA is at time t (% of residue CP), t is incubation time in (h),  $A_{max}$  is the maximum extent of bacterial colonization (% of residue CP) at  $t\approx\infty$ , and R is the rate of colonization (/h). Values for  $A_{max}$  and R were calculated as:

Instead of NDF, in this study, Amax and R were calculated using aNDFom.

To represent OM and CP degradation over time, the exponential model of McDonald (1981) was adapted to CDI (g/kg), separately for every animal as:

where deg describes the cumulative degradation (g/kg) of OM or CP at time t, a represents the soluble fraction (g/kg), b the insoluble but potentially degradable fraction (g/kg), c the degradation rate of b (/h) and L the lag phase (h). Potential degradation is the sum of a and b fraction (asymptote of the curve) and is referred as a+b fraction (g/kg), which was constrained to not exceed 1000 g.

Effective degradability of CP (**ED**<sub>k</sub>**CP**; g/kg CP) and OM (**ED**<sub>k</sub>**OM**; g/kg OM) was calculated for ruminal passage rates (*k*) of 0.02, 0.04 and 0.06/h (indicated as e.g., ED<sub>2</sub>CP, ED<sub>4</sub>CP and ED<sub>6</sub>CP, respectively) according to McDonald (1981), but with the assumption that no degradation occurred during the lag phase (Wulf and Südekum, 2005):

Effective RUCP (**RUCP** $_k$ ) was calculated for k = 0.02, 0.04 and 0.06/h (i.e., RUCP<sub>2</sub>, RUCP<sub>4</sub>, RUCP<sub>6</sub>, respectively) as follows:

The amount of effective prCP *in situ* (**prCP**<sub>k</sub> *in situ*; g/kg OM) was calculated by the sum of RUCP<sub>k</sub> (g/kg OM) and effective MCP (**MCP**<sub>k</sub>) synthesized in the rumen (g/kg OM) for the respective passage rates as:

where MCP<sub>k</sub> was assumed to be 181 g per kg fermented OM (**FOM**; Lebzien and Voigt, 1999). The amount of FOM derived from *in situ* incubations was defined as ED<sub>k</sub>OM minus the amounts of lactate and of propane-1,2-diol (g/kg OM), since lactate and propane-1,2-diol being themselves end products of microbial fermentation and therefore providing only a negligible amount of energy to rumen microbes (AFRC, 1993). The volatility of lactate and of propane-1,2-diol can be regarded as very small and therefore still present after freeze-drying, whereas all other fermentation acids and alcohols are completely volatile and no longer present in the incubated material.

#### 2.3.4 In vitro procedure

The modHGT used in this study was performed as described in detail by Edmunds *et al.* (2012a). The procedure essentially corresponds to the Hohenheim gas test (**HGT**; Menke and Steingaß, 1988) with the modifications proposed by Steingaß and Südekum (2013) and is used for the *in vitro* estimation of prCP, which is the sum of RUCP and MCP. Rumen-fluid for incubation was taken from two rumen-cannulated German Black Pied heifers 1 h prior to the morning feeding. The heifers were fed a ration consisting of 3 kg of grass hay and 3 kg of concentrate divided into two equal meals (08:00 and 16:00 h). The concentrate contained (g/kg as fed) 232 rye, 210 rapeseed meal, 185 maize gluten feed, 150 milled barley grain, 120 rye bran, 45 beet pulp, 40 maize, and 11 calcium carbonate. Additionally, animals received 75 g of

mineral premix during morning feeding and water was offered for ad libitum consumption. The *in vitro* incubation was conducted in three runs in different days. Samples were weighed (200  $\pm$  1 mg, on fresh matter basis) in duplicate and transferred into 100-mL glass syringes fitted with pistons (Haeberle Labortechnik GmbH & Co. KG, Lonsee-Ettlenschieß, Germany). Additionally, two replicates of standard feeds, and two blank syringes containing only rumen-fluid and no substrate for every run and incubation time were used. Samples were incubated for 8, 24 and 48 h. Standard feeds with defined gas production at 24 h of incubation (hay: 45.9 ml/200 mg DM, concentrate: 61.1 ml/200 mg DM) and defined prCP content at 8 and 48 h of incubation (232 and 97 g/kg DM, respectively) were provided by the Institute of Animal Science, Hohenheim University, Germany. Hay and concentrate standards were used for correcting gas production at 24 h of incubation. Post-rumen CP standard served as a control only, without correction of the measured prCP values. Blank syringes were used to correct for gas production after 24 h of incubation and NH<sub>3</sub>-N content originating from rumen-fluid buffer solution after 8 and 48 h of incubation. After 8, 24 and 48 h gas volume was measured, and the syringes were immediately put on ice to suppress further microbial activity. Subsequently, NH<sub>3</sub>-N content was determined by steam distillation as described by Westreicher-Kristen et al. (2015). The prCP content determined by the modHGT was calculated according to the following equation:

where NH<sub>3</sub>-N<sub>blank</sub> is the NH<sub>3</sub>-N amount of the blanks after incubation (mg), N<sub>sample</sub> is the N amount of the incubated sample (mg), NH<sub>3</sub>-N<sub>sample</sub> is the NH<sub>3</sub>-N amount of the liquid contained in the syringes after incubation (mg) and S is the total amount of sample on DM basis (mg), OM refers to the OM content of the incubated sample (g/g DM).

The effective prCP *in vitro* (**prCP**<sub>k</sub> *in vitro*) was calculated through linear regression of prCP values at 8 h and 48 h of incubation against ln time (h) and calculating the function value for ln (50), ln (25) and ln (16.7) for each passage rate 0.02, 0.04 and 0.06/h.

Gas volume after 24 h of incubation was used to calculate amount of metabolizable energy (ME; GfE, 2008):

where CA, CP, EE and ADFom are expressed as g/kg DM. GP24 is gas production at 24 h (ml/200 mg DM).

# 2.3.5 Statistical analysis

The *in situ* parameters (a, b, c, L) were estimated for each of the three animals via software program GraphPad Prism (version 8.00 for Windows, GraphPad Software Inc., San Diego, CA, USA). Linear mixed-effects models (Pinheiro and Bates, 2000) were used to compare target values using Software R (version 3.6.1, The R Foundation for Statistical Computing, Vienna, Austria). The statistical model included inoculant (categorical variable), DM concentration (DM, categorical variable) and their interaction as fixed effects and a random effect for animal (in situ) or run (in vitro). Comparison of the data was done using two-way analysis of variance to identify treatment effects. Additionally, multiple contrasts tests (Bretz et al., 2010; Hothorn *et al.*, 2008) were used to test for a changepoint effect of DM concentration on response variables. Furthermore, linear mixed-effects models were used as described before, where DM was included as a continuous variable. Analysis of covariance was conducted to identify treatment effects. All reported values are least squares estimates (means, intercepts, slopes) and significance was declared at P < 0.05. Two coefficients of determination (R<sup>2</sup>) are given, where marginal R<sup>2</sup> (R<sup>2</sup><sub>m</sub>) describes the proportion of variance explained by the fixed factors (inoculant, DM) alone, and conditional R<sup>2</sup> (R<sup>2</sup>c) describes the proportion of variance explained by both the fixed and random factors.

#### 2.4 Results

# 2.4.1 Chemical composition of the silages

Chemical composition and fermentation pattern results of the silage samples are shown in **Table 2-1**. Low contents of butyric acid (<3 g/kg DM) and NH<sub>3</sub>-N (<80 g/kg CP) indicate high quality of most silages. High proportion of acetic acid (71.1 g/kg DM) and propane-1,2-diol (42.3 g/kg DM) was found for LAB-170, which also was

the only treatment where meaningful contents of propionic acid (6.23 g/kg DM) and n-propanol (9.65 g/kg DM) could be detected.

The sum of fermentation acids and alcohols decreased with increasing DM (P<0.001) for both treatments (CON: 184 to 48.6 g/kg DM; LAB: 193 to 60.1 g/kg DM), with on average higher amounts of fermentation products for LAB (114 g/kg DM; P<0.001) compared to CON (89.7 g/kg DM). The concentration of WSC increased with increasing DM (P<0.001) for CON (from 9 to 66 g/kg DM) and LAB (from <0.1 to 48.8 g/kg DM). Consequently, pH value increased with DM and was higher for CON compared to LAB (P<0.001). Average NH<sub>3</sub>-N concentration was higher for CON (11.9 g/kg CP) compared to LAB (10.7 g/kg CP; P<0.001). Significant interactions between DM and inoculant were found for each parameter except for ethanol concentration. The interactions were not caused by a systematic effect of DM or inoculant, they occurred in some single treatments only.

# 2.4.2 In situ OM and CP degradation and prCP concentration

The effect of silage DM and inoculant on *in situ* OM degradation parameters are given in **Table 2-2**. Average of *a* fraction was higher for CON (P<0.001) compared to LAB (295 and 277 g/kg OM, respectively) whereas *b* fraction was lower for CON (P<0.001) than LAB (576 and 595 g/kg OM, respectively). Interaction (P<0.001) was caused by a more pronounced deviation of *a* and *b* fraction between the treatments at lower DM compared to higher DM. There were no differences between CON and LAB for a+b values (P = 0.92), whereas a non-systematic effect of DM (P<0.001) was observed. The effective FOM¹ increased with DM concentration (P<0.001) and was higher in CON compared to LAB (P<0.001), whereas interaction (P<0.001) was not specific. Faster passage rates numerically reduced effective FOM.

For a and b values of CP (**Table 2-2**), changepoints (data not shown) existed between DM-530 and DM-580 (P<0.001): Fraction a averaged 648 and 627 g/kg CP within the DM range of 170 – 530 and decreased to 594 and 587 g/kg CP at the DM range of 580 – 600 for CON and LAB, respectively. Fraction b averaged 312 and 334 g/kg CP within the DM range of 170 – 530 and increased to 371 and 375 g/kg CP at the DM range of 580 – 600 for CON and LAB, respectively. These differences below and above this changepoint are also reflected by the content of effective RUCP. Depending on treatment and on assumed passage rate, effective RUCP was enhanced (P<0.001) by 3.7 to 13 g/kg CP at the DM range of 580 – 600 compared to DM range of 170 – 530. Average amounts of RUCP<sub>2</sub>, RUCP<sub>4</sub>, and RUCP<sub>6</sub> were 79, 110 and 137 g/kg CP for CON, and 82, 115 and 142 g/kg CP for LAB.

The contents of MCP and RUCP required for calculating the effective prCP *in situ* and values of *in vitro* determined effective prCP are shown in **Table 2-3**. For most of these parameters' significant interaction of DM and inoculant were observed. To assist understanding and to quantify the effects of DM and inoculant linear regression equations are given in **Table 2-4**. Irrespective of assumed passage rate, MCP linearly increased (P<0.001) by 2.3 g/kg OM per 100 g DM increase, where CON had higher intercepts, reflecting the higher MCP for CON (P<0.001, **Table 2-3**). With increasing passage rate MCP numerically decreased. Similar linear effects of DM existed for effective prCP *in situ* (P<0.001) and are more pronounced (steeper slopes) at higher passage rates.

The *in vitro* estimated prCP<sub>2</sub>, prCP<sub>4</sub> and prCP<sub>6</sub> increased linearly with increasing DM content (*P*<0.001). However, at lower passage rates intercepts numerically decreased, whereas slopes numerically increased, which reflected a higher sensitivity of the *in vitro* method at lower passage rates. No effect of inoculant on effective prCP *in vitro* could be detected.

The effects of animal and run on effective prCP values reveal the necessity of either using a respective standard feed to correct for these effects or of performing multiple runs in different days (*in vitro*) or multiple runs in several animals.

# 2.5 Discussion

# 2.5.1 Effect of wilting

In general, high DM content results in an increased osmotic pressure which suppresses proteolytic activity of plant-based enzymes (McDonald et al., 1991; Slottner and Bertilsson, 2006). Therefore, soluble CP (fraction a) decreases, while insoluble but potentially degradable CP (fraction b) increases in wilted silages (Tamminga et al., 1991; Verbič et al., 1999). Indeed, a similar trend was observed in this study and an effect of DM on CP fractions a and b was reflected by a changepoint between the range of DM-170 to DM-530 and DM-580 to DM-600. The latter resulted in increased effective RUCP (g/kg CP) for all passage rates by showing the same DM changepoints, indicating reduced proteolysis in highly wilted silages. However, within the respective ranges no effect of DM was found for a, b, or effective RUCP. In accordance with this, Edmunds et al. (2014) have demonstrated that RUCP<sub>3</sub> increases through intensive wilting (DM-650), without any effect in less intensive wilted (DM-200, DM-350, DM-500) silages. However, DM effect observed by Edmunds et al. (2014) was more pronounced (46 to 61 g RUCP<sub>3</sub>/kg CP) than in the present study (9 g RUCP<sub>4</sub>/kg CP). Also, mean RUCP<sub>4</sub> was higher (160 ± 38 g/kg CP; Edmunds et al., 2012b) as observed here (113  $\pm$  5 g/kg CP). The differences between the studies might be explained by many factors, such as plant material, cut number, maturity or wilting conditions including processing time. Silages examined by Edmunds et al. (2012a) composed of meadow grass (approx. 0.80 grass, 0.10 legumes and 0.10 herbs; second harvest) with on average higher CP (189 g/kg DM) than in the present study (152 g/kg DM). Additionally, processing procedure took less time compared to our study. Highly wilted silage samples (DM-650) were prepared during 50 h (Edmunds et al., 2014), whereas in this study about 10 h more were needed to produce samples with 600 g DM. The authors highlighted a positive effect of a shortened and more intensive wilting on effective RUCP and effective prCP in vitro (Edmunds et al., 2014), which can also be assumed to be responsible for the deviation of values determined for effective RUCP and effective prCP and the strength of DM effect compared to our study. Possibly, a part of the deviations could be attributed to a missing or false correction for microbial contamination. It has been shown that the correction according to Krawielitzki et al. (2006) used here overestimates the maximum extent of bacterial colonisation (Amax) of grass silage (Edmunds et al., 2012b). Therefore, a slightly higher content of effective RUCP might be more realistic, although this does not fortify the effect of DM.

The wilting process reduced microbial fermentation of WSC during ensiling and consequently concentration of fermentation acids, which is consistent to the literature (Gordon *et al.*, 2000; Johansen *et al.*, 2017; Purwin *et al.*, 2009). Due to this positive effect of wilting on WSC content, effective FOM increased in by increasing DM concentration indifferent of passage rate. Because MCP is calculated based on effective FOM, its increase through wilting was mainly caused by the variation in the concentrations of fermentation acids and WSC. Johansen *et al.* (2017) studied the effect of pre-wilting of grass-clover silages on duodenal nutrient flow in lactating dairy cows. They reported a linear increase of duodenal flow of MCP by 3.2 g/kg DM, while DM of silages increases by 100 g. Also, Verbič *et al.* (1999) reported higher supply of microbial N in highly wilted silages (DM-520) compared to unwilted (DM-210) or moderately wilted silages (DM-430) calculated based on purine derivate excretion in sheep. In contrast, Merchen and Satter (1983) did not find significant differences in the MCP flow in cows fed alfalfa silages varying in a range of DM-290 to DM-660.

The effect of DM on effective prCP in situ was mainly caused by the extent of increased MCP and the proportion of MCP in prCP. The MCP accounted for 77% (k =0.06/h) to 90% (k = 0.02/h) of effective prCP in situ. Moreover, while DM had only a small effect on effective RUCP (g/kg OM), the absolute MCP increased in average 9% (k = 0.02/h) and 15% (k = 0.06/h) with increasing the DM content. The latter resulted in 9 and 12% increases of effective prCP for the same passage rates. These effects on effective prCP in situ were confirmed by the linear increase of effective prCP in vitro with DM (P<0.001; **Table 2-4**), where prCP<sub>6</sub> in vitro showed the best agreement (similar slopes of the linear regression equations). The positive effect of DM agrees with results of Bakken et al. (2017) who showed a negative relationship between the concentration of total acids and prCP<sub>4</sub> in vitro, showing that intensively wilted silages contain smaller amounts of fermentation acids and a higher amount of WSC. Similarly, Edmunds et al. (2014) observed elevated values of prCP4 in vitro in grass silages pre-wilted to DM-650 (136 g/kg DM), whereas no effect of DM on prCP<sub>4</sub> in vitro occurred between DM-350 (128 g/kg DM) and DM-500 (130 g/kg DM). In contrast, wilting lucerne silages prior to ensiling (DM-250 and DM-350) had no effect on effective prCP in vitro at passage rates of 0.02 and 0.05/h and tended to be higher for DM-250 at passage rate 0.08/h (Hartinger et al., 2019). The authors assumed that the missing effect on effective prCP in vitro was caused by a generally limited availability of WSC in the silages to reuse ammonia-N from CP degradation for MCP synthesis. Despite of the statistical significance of the effect of DM on

effective prCP values in this study, the biological relevance with 2.3 to 4.9 g/kg OM per 100 g DM increase is small.

## 2.5.2 Effect of inoculant

Compared to CON, soluble CP (fraction *a*) reduced and the slowly degradable CP (fraction *b*) increased in LAB, indicating reduced proteolysis, as also reflected by the lower NH<sub>3</sub>-N content in LAB silages. This was probably due to a faster drop in pH value after ensiling and a lower final pH by using the inoculant. Consequently, pH-dependent plant enzymes and fermentation organisms were suppressed earlier (McDonald *et al.*, 1991; Muck *et al.*, 2018). Therefore, average effective RUCP enhanced for LAB by 3 g/kg CP at a passage rate of 0.02/h and by 5 g/kg CP at passage rate 0.04 and 0.06/h. Kramer (2011) reported a greater effect of 20-60 g RUCP/kg CP in first-cut grass silages varying in a range of DM-200 to DM-500. However, RUCP values were estimated using the Cornell Net Carbohydrate and Protein System (CNCPS), which is based on the chemical fractionation of CP and not on ruminal parameters from *in situ* incubations.

Due to the higher concentration of acids and lower WSC content in LAB, the amount of FOM in LAB was lower compared to CON, resulting also in lower calculated amount of MCP for LAB. However, higher RUCP (g/kg OM) in LAB compared to CON compensated to some extent for the calculated lower MCP yield. Nevertheless, effective prCP in situ was lower in LAB irrespective of passage rate. However, the decrease in effective prCP by using LAB cannot be generalised for silages. Moreover, although significant, the differences between CON and LAB were small in absolute terms and to a certain extent depending on the underlying assumptions, e.g., the efficiency of MCP synthesis. Additionally, results of the modHGT indicated no difference in effective prCP between CON and LAB for any chosen passage rate. Even if no increase in effective prCP content in grass silage could be shown by LAB in our study, the use of such inoculants is beneficial due to other well-known positive effects on silage quality which were confirmed by this study. The increase of butyric acid concentration in high wilted silages was suppressed by LAB, which might be even much more pronounced under practical conditions. Furthermore, LAB silages showed higher acetic acid concentration due to the combination of homo- and heterofermentative lactic acid bacteria, which resulted in a greater aerobic stability (data not shown).

## 2.5.3 Relationship between in situ and in vitro prCP values

The protein value of feeds for ruminants is mainly determined by their amounts of prCP. The flow of prCP to the duodenum can be measured in vivo with duodenal fistulated animals or estimated from results of ruminal in situ incubations as done in our study. Both procedures are more expensive, laborious, and time-consuming than in vitro measurements. Therefore, this study also aimed at evaluating the potential of the modHGT to show similar treatment effects as observed with the *in situ* method. Function values for effective prCP (Table 2-4) calculated for DM-350 were lower for in vitro than in situ at low passage rates, and vice versa. Effective prCP in *vitro* was lower with 28 g at k = 0.02/h and higher with 26 g/kg OM at k = 0.06/h than effective prCP in situ. Assuming a passage rate of k=0.04/h, which seems to be realistic for forages (Sauvant and Nozière, 2016; Tamminga et al., 2007), both methods resulted in similar function values for effective prCP (in vitro: 125 g; in situ: CON 121 g, LAB 118 g/kg OM). It should be emphasized that despite the distinctly different general conditions of both methods the prCP<sub>4</sub> values (**Table 2-3**) differed only by approximately 7 g/kg OM on average. As noted above, the microbial contamination might have been overestimated in this study, which would have led – if correctly estimated – to higher effective prCP in situ, furthermore, reducing the difference between the *in situ* and *in vitro* determined prCP<sub>4</sub>. The differences in effective prCP values between methods were mainly caused by the assumed passage rate and supports previous observations (Edmunds et al., 2012a; Westreicher-Kristen and Südekum, 2018). Edmunds et al. (2012a) examined several forages (i.a. white clover, lucerne, perennial ryegrass) differently conserved (unconserved, hay, silage and artificially dried). They reported lower values for effective prCP in vitro at k = 0.02/hand higher values at k = 0.06/h than effective prCP values determined according to GfE (2001), however a good agreement at k = 0.04/h (Edmunds *et al.*, 2012a). Westreicher-Kristen and Südekum (2018) determined effective prCP of total-mixed rations composed of maize silage, red clover silage, lupine seeds, soybean meal and wheat, having a forage to concentrate ratio of 0.75:0.25. The authors reported higher values of effective prCP determined according to GfE (2001) for k = 0.02/h and k = 0.05/hcompared to effective prCP in vitro, whereas minimal differences occurred at k =0.08/h. To receive a more detailed comparison between both methods, effective prCP values obtained in situ were regressed against those estimated in vitro (data not shown). In situ prCP correlated with prCP in vitro at all rates of passage (k =0.02/h: P<0.001,  $R^2 = 0.58$ ; k = 0.04/h: P<0.001,  $R^2 = 0.61$ ; k = 0.06/h: P<0.01,  $R^2 = 0.54$ ), in spite of the very near range of the values (**Table 2-3**). This relationship was most pronounced at k = 0.04/h and can be described by the following equation: prCP<sub>4</sub> in situ (g/kg OM) =  $41.2\pm17.3 + 0.63\pm0.13 \times \text{prCP}_4$  in vitro (g/kg OM). In accordance with these observations, Edmunds *et al.* (2012a) reported for different forages increasing correlation coefficients with passage rate (k = 0.02/h: P<0.038,  $R^2 = 0.19$ ; k = 0.04/h: P<0.001,  $R^2 = 0.56$ ; k = 0.06/h: P<0.001,  $R^2 = 0.67$ ). Westreicher-Kristen and Südekum (2018) found no correlation at k = 0.02/h ( $R^2 = 0.72$ , P = 0.15), but a close correlation at k = 0.05/h ( $R^2 = 0.94$ , P = 0.03) and k = 0.08/h ( $R^2 = 0.95$ ; P = 0.02) for total-mixed rations.

Although the *in vitro* method does not realise the true situation in the rumen, it better reflects the differences in the availability of energy from fermented nutrients for microbial growth, as shown for the negative impact of higher RUCP on MCP (Ipharraguerre and Clark, 2005; Tamminga, 1982). Furthermore, it avoids the unsolved problem of the *in situ* method with regard to non-additivity of RUCP and MCP as outlined by GfE (2001). Since passage rate positively affects both the efficiency of MCP synthesis as well as RUCP, effective prCP *in vitro* might represent a more accurate measurement than using a constant efficiency for calculating of MCP.

#### 2.5.4 Limitations of the *in situ* and *in vitro* methods

This chapter aims to address some of the main limitations of the *in situ* and *in vitro* method used in the present study. The *in situ* incubation technique is well suited to describe ruminal degradation of chemical constituents of feeds over time. Although this technique is widely used in several protein systems, some critical points still remain not satisfactory solved. The strength of in situ measurements are the exposure of feeds to ruminal conditions similar to those in vivo (Schwab et al., 2003). Extensive research on forage evaluation was performed frequently focused on the assessment of factors reducing ruminal degradation of CP (Huhtanen, 2019; Huhtanen and Broderick, 2016). Although variations of RUCP concentration of forage detected by the *in situ* method are present, there is limited evidence that these differences are reflected in animal performance, which partly can be explained by inherent problems of the in situ method related to the soluble CP fraction and microbial contamination. The general assumption that the soluble fraction of CP is completely degraded in the rumen is evidently questionable, because there are indications that a considerable part of soluble non-ammonia N (free amino acids, peptides, and soluble proteins) reaches the small intestine undegraded (Ahvenjärvi et al., 2018; Volden and Larsen, 2011). The soluble protein pool is reassigned to the outflow of the liquid phase of the rumen in the CNCPS (van Amburgh *et al.*, 2015) due to its high passage rate (Seo et al., 2006; Volden and Larsen, 2011). Therefore, it can be assumed that RUCP values in our study were underestimated to a certain extent. On the other hand, RUCP content might be overestimated, if microbial contamination of residues in the bags is not considered, especially relevant in fibre-rich feeds of low N content (Krawielitzki *et al.*, 2006; Tamminga *et al.*, 1991). According to the equation proposed by Krawielitzki *et al.* (2006), 14 to 64% of the residual CP consisted of microbial CP in the present study for incubation times of 2 to 72 h. This means that e.g., RUCP<sub>4</sub> ranged between 169-200 g/kg CP without and between 105-122 g/kg CP with correction for microbial CP contamination. However, it was proven that the mentioned equation overestimates the maximum extent of bacterial colonisation of grass silage (Edmunds *et al.*, 2012b) which probably leads to a slightly higher content of effective RUCP. The latter might partially explain some differences between *in vitro* and *in situ* results at certain passage rates.

The prerequisite for estimating MCP synthesis is the precise information about the amount of energy available to the rumen microbes. A correction for substances which escape the bag, however, are not used as energy source for microbial growth (AFRC, 1993; Tamminga et al., 2007; Vérité and Peyraud, 1989), e.g., fermentation acids, seems to be necessary when calculating MCP from EDkOM determined in situ. In our study, ED&OM was corrected for lactate and propane-1,2-diol, other fermentation products during ensiling were negligible and volatile during drying. Assuming a factor of 181 g MCP/kg FOM generated plausible values in the present study. However, the absolute value must be critically discussed, and the assumption of a constant efficiency of MCP yield is even more questionable. Rather, the efficiency of MCP yield depends on many factors such as the fractional rumen passage rates of the liquid, solid, concentrate and forage fraction (Thomas, 2004), the feed components as well as their fractional degradation rates (Tamminga et al., 2007), DM intake (Volden, 2011), and the type of degraded substrates (van Duinkerken et al., 2011). Among these factors passage rate plays a prominent role, since it affects microbial efficiency by affecting the energy requirement for maintenance of the microbes (Hackmann and Firkins, 2015). Therefore, this simplification by omitting different fractional passage rates of the liquid and solid phase is one of the main limitations. On the other hand, the missing outflow is a substantial disadvantage of closed in vitro-systems in which both, nutrient supply and removal of degradation products do not occur, affecting the activity of the microbial population (Gidlund et al., 2018; Westreicher-Kristen and Südekum, 2018). Additionally, at long incubation times (low passage rates) effective prCP in vitro decreases due to progressive feed CP degradation and lysis of microbes (Steingaß and Südekum, 2013). Therefore, short in vitro incubation times (corresponding to passage rates at high feed intakes) result in more reliable estimates of *in vivo* MCP synthesis (Westreicher-Kristen and Südekum, 2018).

It is an obvious limit of the present study, that two indirect methods were compared against each other, since as mentioned above the *in situ* method cannot be considered as an absolute reference. However, it can serve as a guide due to its widespread use (GfE, 2001; NRC, 2001; Thomas, 2004; van Duinkerken *et al.*, 2011), whereas its high effort prevents routine application. The present study was designed to evaluate the effects of wilting and inoculant application on RUCP, MCP and prCP. Although the study does not give protein values of grass silages directly applicable for ration formulation, it provides a valid indication about the effect of wilting and inoculant administration on the protein value of grass silage for dairy cows.

In vivo experiments using animals fitted with an abomasal or a duodenal cannula (Huhtanen, 2005) might be seen as the most appropriate method to generate true feed protein values. Besides the need for surgically prepared animals, digesta flow and microbial markers are required to measure microbial protein synthesis (Huhtanen, 2005), which are regarded as potential sources of several errors (Hristov et al., 2019). The ultimate method to define the protein value of a diet is the measurement of the response in milk protein yield of lactating animals (Huhtanen and Broderick, 2016). However due to the enormous effort, such trials are not suitable for routine evaluation. Furthermore, since various factors affect protein yield, it is difficult to formulate diets where protein supply is the first-limiting factor. Nevertheless, in future a small number of such studies should be performed to calibrate in vitro and in situ measurements.

### **Conclusions**

The positive effect of wilting on RUCP concentration of grass silages as reported in the literature was confirmed by our results, although the effects were less pronounced in our study. Despite statistically significant the effect of wilting on effective prCP was small in absolute terms and can be considered as biologically not meaningful. Inoculant containing LAB increased RUCP content to a small extent, whereas effective prCP remained unaffected. Although representing real fermentation conditions in the rumen less accurately, the modHGT shows some significant advantages over the *in situ* method – besides better suitability for routine analysis – which are the potential to better reflect the incomplete additivity of RUCP and MCP and avoiding the problematic simplification of assuming a constant efficiency of MCP synthesis.

# In situ and in vitro determination of the protein value of feeds for ruminants<sup>1</sup>

#### 3.1 Abstract

The objective of this study was to estimate the amount of post-rumen crude protein (prCP), a precursor to metabolisable protein for ruminants, of feeds and feed mixtures using an in situ and in vitro method, and to contrast the results of both approaches. For this, 34 samples were examined: 9 feeds, 13 feed mixtures made thereof, and 12 feed mixtures provided by commercial dairy farms. As a minor aspect, additivity of protein values from feeds was evaluated by comparing measured and calculated values of feed mixtures. Effective prCP was calculated for assumed rumen passage rates (k) of 0.05/h (prCP<sub>5</sub>) and 0.08/h (prCP<sub>8</sub>) by in situ measurements of rumen undegraded CP and fermented organic matter (FOM) assuming an efficiency of 181 g microbial CP/kg FOM. Additionally, effective prCP in vitro was estimated using the modified Hohenheim gas test (modHGT) through incubation in rumen-fluid buffer solution for 8 h and 24 h followed by ammonia distillation. *In* vitro estimations were highly correlated with in situ values for both passage rates  $(k = 0.05/h: P < 0.001, R^2 = 0.68; k = 0.08/h: P < 0.001, R^2 = 0.76)$ . The in vitro method yielded higher values for effective prCP than the in situ approach with 29 g/kg OM (k = 0.05/h) and 37 g/kg OM (k = 0.08/h) on average for all samples. Small positive associative effects - reflecting non-additivity - were found, averaging at 2.2 g prCP<sub>8</sub>/kg OM (p<0.05) for the *in situ* and 10.7 g prCP<sub>8</sub>/kg OM (P<0.001) for the *in* vitro approach. Due to the need of an assumption of a certain value for microbial yield in situ, effective prCP might be more accurately estimated in vitro, accounting for nutrient-specific efficiencies as well as interactions between carbohydrate and protein degradation by rumen microbes. Furthermore, the modHGT highlighted associative effects more pronounced and seems suitable as a routine method due to the comparably low effort and high sample throughput. The potential of the modHGT to determine the protein value of feeds could be demonstrated by our study.

#### 3.2 Introduction

Protein requirement of dairy cows should be precisely met by feeding, to avoid negative effects on health and performance, and to minimize excess N and consequently environmental pollution (Dijkstra *et al.*, 2013; Hristov *et al.*, 2019). In this context, one of the key variables in feed evaluation is the content of post-rumen crude protein (**prCP**) corresponding to the sum of rumen undegraded CP (**RUCP**) and microbial CP synthesized in the rumen (**MCP**), which is referred to as utilisable crude protein at the duodenum (**uCP**, **nXP** in German) in the German protein evaluation system (GfE, 2001).

The *in situ* technique is a frequently used method to estimate RUCP, but high effort and limited sample throughput prevent its routine application. However, MCP yield has to be estimated from variables describing the amount of energy available for microbial growth (Edmunds et al., 2012). This estimate differs between protein evaluation systems, for example, MCP is calculated as a function of digestible organic matter (DOM; NRC, 2001) or using DOM corrected for substances that provide little or no energy to rumen microbes, such as fermentation products in silages, ether extract (EE), RUCP (Vérité and Peyraud 1989) and bypass starch (Tamminga et al., 1994). Furthermore, microbial efficiency depends on a variety of factors such as feed fractions (soluble, degradable, non-degradable), properties of the feeds (forage vs. concentrate) and kind of fermented nutrients (van Duinkerken et al., 2011). Thus, the estimate of MCP yield is variable, associated with various assumptions and consequently limited in its accuracy, which is especially crucial, since MCP is quantitatively more important than RUCP (Steingaß and Südekum 2013). Furthermore, Voigt and Piatkowski (1987) reported an interaction between measurements of RUCP and MCP, thus a more accurate assessment of the protein value might be received by a measurement of total prCP. The modified Hohenheim gas test (modHGT, Steingaß and Südekum, 2013) offers a simple method to estimate prCP from ammonia N concentration of samples incubated in rumen-fluid buffer solution and bypasses the need to estimate RUCP (Südekum and Böttger 2019). Gidlund et al. (2018) described a close relationship between in vitro determined prCP and omasal flow of CP in lactating dairy cows, while previous studies confirmed the reliability of the modHGT (Edmunds et al., 2012; Westreicher-Kristen et al., 2015) in comparison to reference values calculated based on GfE (2001).

*In vitro* methods provide an alternative to *in vivo* or *in situ* studies, which are criticized for animal welfare reasons, and simplify standardization while giving the possibility for routine application.

Moreover, the occurrence of associative effects on *in vitro* prCP in feed mixtures was demonstrated by Zhao *et al.* (2005) and the above-mentioned multiple influences on MCP synthesis such as nutrient specific efficiencies might also be considered *in vitro*.

The aim of this study was to validate the suitability of the modHGT in estimating prCP *in vitro* from different feeds and feed mixtures, where prCP estimated using *in situ* RUCP and estimates of MCP (based on *in situ* measurements of fermented organic matter, **FOM**) served as reference. It was hypothesised that the modHGT yields in prCP values like those received by the *in situ* method and additionally shows advantages regarding practicability and sensitivity to influences on MCP synthesis and interactions between OM and CP degradation.

#### 3.3 Materials and methods

The studies reported here were conducted in accordance with the German Animal Welfare Act (Federal Republic of Germany, 2014). The *in situ* ruminal degradation experiment was performed at the Department of Animal Nutrition of the Hohenheim University, Stuttgart and was approved by the Regional Council Stuttgart of the Ministry of Rural Areas and Consumer Protection of the federal state Baden-Württemberg, Germany. The *in vitro* incubation was carried out at the Institute of Animal Nutrition and Physiology of the Christian-Albrechts-Universität, Kiel and the collection of rumen-fluid from fistulated heifers was approved by the Animal Welfare commission of the Ministry of Energy, Agriculture, Environment, and Rural Areas of the federal state of Schleswig-Holstein, Germany.

## 3.3.1 Samples

Nine feeds: grass silage (freeze-dried), maize silage (freeze-dried), grass hay, wheat straw, corn, dried distillers' grains with solubles (**DDGS**), rapeseed meal, soybean meal, and sunflower meal were used for lab scale production of 13 feed mixtures (500 g DM each, **Table 3-1**) added with mineral mixture and subsequently ground to pass through a 4 mm screen. The formulation aimed to cover a large variety of feed mixtures and a range of about 120 to 210 g CP/kg DM. Feed mixtures were numbered from 1 to 13 based on increasing CP concentration. Additionally, 12 feed mixtures provided by commercial dairy farms (freeze-dried) covering a broad range of different diets were used, which were numbered from 1 to 12 according to their CP concentration and are hereinafter referred to as "commercial feed mixtures".

Chemical composition of the 9 feeds and 25 feed mixtures used for in situ and in *vitro* incubation is given in **Table 3-2**. All samples were analysed for DM, crude ash (CA) and CP according to the official analytical methods in Germany (methods 3.1, 8.1 and 4.1.1, respectively; VDLUFA, 2007). Organic matter was calculated as 1000 - CA, where CA is in g/kg DM. Feeds and feed mixtures were analysed according to VDLUFA (2007) for neutral detergent fibre (assayed without a heat stable amylase and expressed exclusive of residual ash, NDFom; method 6.5.1), acid detergent fibre (expressed exclusive of residual ash, ADFom; method 6.5.2), acid detergent lignin (ADL; method 6.5.3) and sugar (method 7.1.1). Starch was quantified after enzymatic hydrolysis and subsequent oxidation by glucose oxidase as described by Brandt et al. (1987). Prior to analysis, samples were ground to pass through a 1.0mm screen (Retsch centrifugal mill ZM1, Retsch GmbH, Haan, Germany) for DM, CA, CP, and sugar, through a 2.0-mm screen for NDFom, ADFom and ADL, and through a 0.2-mm screen for analysis of starch. NDFom (assayed with a heat stable amylase; aNDFom), ADFom, starch and sugar contents of commercial feed mixtures were determined by Landwirtschaftliche Kommunikations- und Servicegesellschaft mbH, Lichtenwalde, Germany, using near-infrared reflectance spectroscopy.

# 3.3.2 In situ procedure

The *in situ* procedure was conducted using four ruminally cannulated and lactating Jersey-cows with an average body weight of 546 kg and an average milk yield of 18 kg/d. The cows received a mixed ration composed (in kg/kg DM) of 0.25 concentrate mixture (0.27 barley, maize, and faba beans each, and 0.20 peas), 0.24 maize silage, 0.24 grass silage, 0.17 meadow hay, 0.05 rapeseed meal, 0.02 barley straw and 0.02 of a mineral mixture. Feed and water were offered for ad libitum consumption. Mean DM intake was 15 kg/d. For in situ incubations, feed and feed mixtures were ground to pass through a 2 mm sieve (mill: Brabender GmbH, Duisburg, Germany) and about 1.4 g on DM basis of each sample was placed into polyester bags (5 × 10 cm, 50 μm pore size, 14 mg DM sample/cm<sup>2</sup> polyester bag; ANKOM Technology Macedon, NY, USA). Bags were fixed to an anchor weight (600 g) and introduced into the rumen after morning feeding in the ventral sac. Immediately before rumen incubation, bags were soaked in warm tap water (≈39 °C) for 5 min. Six bags per sample and time point were assigned to the four cows (i.e., one or two repetitions each per cow and time point) and incubated for 8, 24 and 48 h. Polyester bags were removed from the rumen after each corresponding incubation time, subsequently immersed in ice-water to stop microbial activity. Additionally, six polyester bags per sample without incubation were used for the determination of the bag content at the initial 0 h time point. All bags (including 0 h bags) were thorough and carefully washed by hand in cold tap water until the water was no longer turbid. Afterwards, bags were freeze-dried, weighted, and stored until analysis of CA and CP (steam distillation).

Water-soluble (**WS**) fraction was measured in quadruplicate by mixing samples (1 g fresh matter) in 50 ml water (37 °C) for 1 min before filtration through filter paper (No. 615 1/4, Ø: 150 mm, Macherey-Nagel, Germany). Water-insoluble fraction escaping from the polyester bags as small particles (**SP**) was calculated by subtracting WS fraction from 0 h washout fraction.

Out of the 6 bag residuals per feedstuff and time point, 3 bags each were used for the determination of CA and CP concentration, respectively. It was assumed that the CA concentration in the 3 bags analysed did not differ from the CA concentration in the 3 bags used for the N determination and *vice versa*. Since variation of N concentration between the 3 residues did account for a negligible small proportion of the variation in CP degradability within feedstuff and time point, mean CP concentration was used for calculating CP degradation for all 6 bags. This implicates

that variation of CP degradability values between bags are nearly completely caused be differences in DM degradability.

Therefore, 6 values of OM and the CP disappearance (**DI**) per feedstuff and time point were obtained and corrected (**C**) for loss of SP according to Hvelplund and Weisbjerg (2000) as:

where CDI, DI, SP and WS are given as fraction (g/g) of OM or CP, respectively.

Subsequently, CDI of CP was corrected for microbial attachment (**MA**) according to Krawielitzki *et al.* (2006) with:

In this study, instead of NDF, A<sub>max</sub> and R were calculated using NDFom for feeds and feed mixtures, and aNDFom for commercial feed mixtures.

Ruminal degradation of OM and CP depending on the time was calculated adapting the exponential model suggested by Ørskov and McDonald (1979) to CDI (g/kg) using the four observations at time points t (t = 0, 8, 24, 48 h) for every animal (n = 4):

where deg describes the cumulative degradation (g/kg) of OM or CP at time t (h), a represents the soluble fraction (g/kg), b the insoluble but potentially degradable fraction (g/kg) and c the degradation rate of b (/h). Potential degradation is the sum of a and b fraction (asymptote of the curve) and is referred as a+b fraction (g/kg), which was constrained to not exceed 1000 g. Lag phase could not be considered due to few incubation time points.

Effective degradability of CP (g/kg CP) and OM (g/kg OM) was calculated according to Ørskov and McDonald (1979) for ruminal passage rates (*k*) of 0.05/h (ED<sub>5</sub>) and 0.08/h (ED<sub>8</sub>) indicated as e.g., ED<sub>5</sub>CP, ED<sub>8</sub>CP, ED<sub>5</sub>OM and ED<sub>8</sub>OM.

The amount of effective prCP *in situ* (**prCP**<sub>k</sub> *in situ*; g/kg OM) was calculated by the sum of RUCP<sub>k</sub> (g/kg OM) and MCP<sub>k</sub> synthesized in the rumen (g/kg OM) for the respective passage rates:

where MCP<sub>k</sub> was assumed to be 181 g per kg effective FOM (Lebzien and Voigt, 1999). The amount of effective FOM derived from *in situ* incubations and corresponds to ED<sub>k</sub>OM of the respective passage rate (g/kg OM) in this study.

## 3.3.3 In vitro estimation of post-rumen crude protein

The *in vitro* estimation of effective prCP was conducted using the modHGT described by Steingaß and Südekum (2013), measuring ammonia production from feed incubated in a rumen-fluid buffer solution. The procedure is described in detail by Westreicher-Kristen *et al.* (2017). Briefly, two rumen-cannulated German Black Pied heifers served as donor animals, where rumen-fluid was taken 1 h prior to the morning feeding. The ration provided to the heifers consisted of (kg DM) 2.6 grass hay and 2.7 of concentrate divided into two equal meals (08:00 and 16:00 h). Composition (g/kg as fed) of the concentrate feed was: 232 rye, 210 rapeseed meal, 185 maize gluten feed, 150 milled barley grain, 120 rye bran, 45 beet pulp, 40 maize and 11 calcium carbonate. In addition, heifers received 75 g of mineral premix during

morning feeding and had *ad libitum* access to water. Ground samples (mill: ZM1, Retsch GmbH, Haan, Germany; sieve size 1 mm) were weighed (200 ± 1 mg, on fresh matter basis) and transferred into 100-mL graduated glass syringes (Haeberle Labortechnik GmbH & Co. KG, Lonsee-Ettlenschieß, Germany) closed airproof with vaseline-greased pistons. Additionally, each run included three blank syringes (containing only rumen-fluid buffer solution and no substrate) and three syringes with a standard sample of known prCP content (prCP-standard). Target values of prCP-standard were 232 and 183 g/kg DM for 8 and 24 h of incubation, respectively. The prCP-standard was provided by the Institute of Animal Science, Hohenheim University, Germany, and served as a control for undisturbed conditions. Two replicates in three runs were carried out for each sample and incubation time (8 and 24 h). At the end of each incubation time, gas volume was measured, and the syringes were immediately put on ice to minimize further microbial activity. Subsequently, NH<sub>3</sub>-N content was determined by steam distillation as described by Westreicher-Kristen *et al.* (2017).

Calculation of prCP *in vitro* using modHGT was done according to the following equation:

where NH<sub>3</sub>-N<sub>blank</sub> is the NH<sub>3</sub>-N amount of the blanks after incubation (mg), N<sub>sample</sub> is the N amount of the incubated sample (mg), NH<sub>3</sub>-N<sub>sample</sub> is the NH<sub>3</sub>-N amount of the liquid contained in the syringes after incubation (mg) and S is the total amount of sample on DM basis (mg), OM refers to the OM content of the incubated sample (g/g DM).

Effective prCP *in vitro* (g/kg OM) was calculated for k = 0.05 and k = 0.08/h through linear regression of prCP values after 8 and 24 h of incubation against ln of time (h) to the values for ln (20) and ln (12.5), respectively.

# 3.3.4 Associative effects on protein value

Additivity of protein values of feeds was tested by comparing the measured values of the feed mixtures (No. 1–13) with the sum of the respective proportions of protein value from feeds used (calculated feed mixtures). Differences in means between measured and calculated feed mixtures were computed for effective RUCP, effective MCP, effective prCP *in situ* and effective prCP *in vitro*.

### 3.3.5 Statistical analysis

The statistical model used included the sample as a fixed effect and a random effect for animal ( $in \ situ$ ) or run ( $in \ vitro$ ), respectively. Linear regressions between effective prCP determined  $in \ situ$  and  $in \ vitro$  were performed and characterized by the coefficient of determination ( $R^2$ ) and the root mean square error (RMSE). Comparison of the mean of feed mixtures (n = 13) and the mean of summed feed mixtures (n = 13) was done using paired t-test. Significant differences for  $in \ situ$  values or effective prCP  $in \ vitro$ , respectively, were considered as associative effects and expressed in the respective unit ( $g/kg \ OM \ or \ g/kg \ CP$ ). All reported values are least squares estimates (means, intercepts, slopes) and significance was declared at P<0.05. Calculations were done using Software R (version 3.6.1, The R Foundation for Statistical Computing, Vienna, Austria).

#### 3.4 Results

#### 3.4.1 *In situ* and *in vitro* measurements

#### **Feeds**

An overview of estimated *in situ* and *in vitro* values of feeds is given in **Table 3-3**. Coefficients of the exponential model (a, b, c) do not reflect the feed properties because of the limited number of incubation time points, rather they are presented for calculating effective degradability. Effective FOM varied from 303 to 774 g/kg OM (k = 0.05/h) and from 237 to 705 g/kg OM (k = 0.08/h), where grass hay, maize silage and wheat straw represented the lower third, DDGS, soybean meal and sunflower meal the upper third.

Effective RUCP was lowest in sunflower meal (189 g/kg CP, k = 0.05/h) and grass silage (240 g/kg CP, k = 0.08/h) and highest in wheat straw (448 and 534 g/kg CP, for k = 0.05 and k = 0.08/h, respectively).

Effective MCP was lowest in wheat straw and highest in soybean meal at both passage rates. Effective RUCP was low (<65 g/kg OM) in grass silage, grass hay, maize silage, and wheat straw and higher (>140 g/kg OM) in rapeseed meal and soybean meal. *In situ* prCP varied between 73 and 306 g/kg OM (k = 0.05/h) and 64 to 346 g/kg OM (k = 0.08/h) with lowest and highest values for wheat straw and soybean meal, respectively. *In vitro* prCP varied in a smaller range from 95 to 266 g/kg OM (k = 0.05/h) and 75 to 297 g/kg OM (k = 0.08/h), with lowest and highest values for wheat straw and DDGS, respectively.

#### **Feed mixtures**

In situ and in vitro values of feed mixtures and commercial feed mixtures are given in **Table 3-4**. Effective FOM varied between 434 and 606 g/kg OM for k = 0.05/h and between 381 and 541 g/kg OM for k = 0.08/h, with mean values of 540 and 472 g/kg OM, respectively.

Soluble CP fraction a was 255 g/kg CP on average, showing a huge margin from 36 to 357 g/kg CP. Potentially degradable CP fraction a+b varied from 859 to 958 g/kg CP. The proportion of effective RUCP averaged at 287 (k = 0.05/h) and 355 g/kg CP (k = 0.08/h) ranging from 231 to 394 g/kg CP and from 290 to 483g/kg CP, respectively.

Effective MCP was 98 (k = 0.05/h) and 85 g/kg OM (k = 0.08/h) on average. Effective RUCP varied in the range of 39.5 to 68.8 g/kg OM (k = 0.05/h) and of 48.0 to 84.2 g/kg OM (k = 0.08/h). Therefore, effective prCP<sub>5</sub> in situ averaged at 148 g/kg OM and varied between 133 and 169 g/kg OM. A slightly lower mean value of 147 g/kg OM was found for prCP<sub>8</sub> in situ. The in vitro method ranked effective prCP values similarly to in situ, but they were generally higher with an average of 184 and 192 g/kg OM for prCP<sub>5</sub> and prCP<sub>8</sub> in vitro.

### 3.4.2 Relationship between in situ and in vitro values of prCP

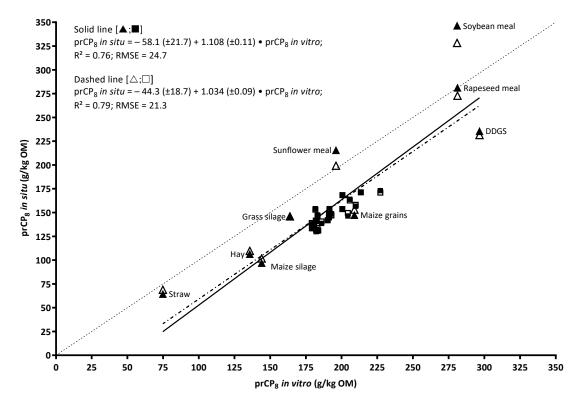


Figure 3-1: Relationship between *in vitro* and *in situ* determined post-rumen crude protein of feeds  $[\blacktriangle, \Delta]$  (n = 9) and feed mixtures  $[\blacksquare, \Box]$  (n = 25) at passage rate of k = 0.08/h (prCP<sub>8</sub>). The dotted line represents the angle bisector. Contents of prCP<sub>8</sub> *in situ* were calculated as the sum of rumen undegraded crude protein (RUCP) and microbial crude protein (MCP) using either one value of 181 g MCP yield per kg fermented organic matter (FOM; filled symbols) or two different values of 208 g MCP/kg crude protein-free FOM and 104 g MCP/kg fermented crude protein (clear symbols).

The differences between *in situ* and *in vitro* values (prCP *in situ* minus prCP *in vitro*) ranged between –47 to 62 g/kg OM (k = 0.05/h) and from –62 to 65 g/kg OM (k = 0.08/h;**Table 3-3**, **Table 3-4**). The largest differences in feeds were observed for soybean meal with 62 g prCP<sub>5</sub> and 65 g prCP<sub>8</sub>/kg OM. The largest differences in feed mixtures were observed for no. 1, no. 6, and no. 4 (commercial feed mixture) with –45 g prCP<sub>5</sub>/kg OM each, and for no. 4 (commercial feed mixture) with –58 g prCP<sub>8</sub>/kg OM. On average of all samples, the modHGT tended to yield higher values of prCP<sub>5</sub> and prCP<sub>8</sub> by 29 and 37 g/kg OM, respectively. Nevertheless, close relationships between *in vitro* and *in situ* determined prCP (n = 34) were found at k = 0.05/h ( $R^2 = 0.68$ , P < 0.001) and k = 0.08/h ( $R^2 = 0.76$ , P < 0.001). The regression equation for k = 0.08/h is: prCP<sub>8</sub> *in situ* = –58.1±21.7 + 1.108±0.11 prCP<sub>8</sub> *in vitro* (**Figure 3-1**; solid line), and the slope is not significantly different from 1. The relationship between *in vitro* and *in situ* prCP for feed mixtures and commercial feed mixtures (n = 25) was also significant at k = 0.05/h ( $R^2 = 0.57$ , P < 0.001) and k = 0.08/h ( $R^2 = 0.70$ , P < 0.001).

# 3.4.3 Associative effects on protein value

A comparison of measured and calculated feed mixtures for effective RUCP, effective MCP, effective prCP *in situ* and effective prCP *in vitro* is given in **Table 3-5**. Additivity is given for all *in situ* values except for RUCP<sub>8</sub> and prCP<sub>8</sub>, where measured values were higher (P<0.05) compared to calculated values but only by 3.3 and 2.2 g/kg OM, respectively. However, effective prCP *in vitro* was higher (P<0.001) with 12.6 (k = 0.05/h) and 10.7 g/kg OM (k = 0.08/h) for measured than calculated feed mixtures, which indicates that modHGT reflected positive associative effects.

### 3.5 Discussion

## 3.5.1 Principles and limits of the methods

The pool of samples used in this study included different forages, concentrates, and protein rich feedstuffs, as well as their mixtures, covering a wide range of contents of CP (38-525 g/kg DM), NDFom (128-810 g/kg DM) and starch (0-628 g/kg DM), which therefore provided a suitable data set for comparison between the *in situ* and *in vitro* approach conducted herein.

The *in situ* technique is an established method to measure particularly ruminal degradation of feeds over time and is often considered as a reference method to estimate CP degradation (Böttger et al. 2019), thus it enables a comparison of different feeds in relation to RUCP content. However, a measurement of MCP yield in situ is unfeasible, for this, in vivo approaches are needed using duodenally cannulated animals. Due to the difficulty and cost of in vivo measurements, MCP yield is usually estimated from variables representing the amount of energy available in the rumen, seen as the main factor responsible for microbial growth (Sauvant and Nozière, 2016). In feed evaluation systems, MCP synthesis is estimated from total tract DOM by NRC (2001), DOM discounting for digestible but non fermented fractions by INRA (2018) or by summation of rumen degraded fractions determined in situ by the NorFor-system (Volden, 2011). In the present study, MCP yield was assumed to be 181 g/kg FOM according to Lebzien and Voigt (1999). These authors determined FOM *in vivo* as the difference between OM intake and OM reaching the duodenum minus microbial OM. In our opinion, FOM determined in situ as reference seems to be a reliable basis and superior to DOM. The predictive value of FOM measured in situ might be improved by correcting for nutrients that do not provide energy for MCP synthesis, such as EE or fermentation products in silages. However, in the present study MCP was calculated using FOM in situ without further corrections, because the figure given by Lebzien and Voigt (1999) is related to uncorrected FOM of mixed rations. Thus, discounting fermentation acids and EE from FOM in our data set would have required respective information, which are not provided for the diets in their study. Indeed, the greatest uncertainties in evaluation of protein value of feeds concern the estimate of MCP (Sauvant and Nozière, 2016), which is quantitatively more important than RUCP (Steingaß and Südekum, 2013) and accounted for 62% on average of effective prCP in situ in feed mixtures of the present study. The fact of non-additivity of RUCP and MCP from independent measurements (Voigt and Piatkowski, 1987) was considered in our study by in situ

measurement of both, RUCP and FOM. The use of a constant efficiency of MCP yield (181 g/kg FOM) results in a decrease of prCP *in situ* with increasing passage rates without consideration of possible changes in efficiency of MCP yield (Krieg *et al.*, 2018). Rather, the efficiency of MCP synthesis differs between liquid, forage and concentrate fractions (Thomas, 2004), and also varies between fermented substrates (starch, NDF, proteins and other carbohydrates; Volden, 2011). On the basis of a meta-analysis, Sauvant and Nozière (2016) confirmed the substrate specific microbial growth, which is already included in the Nordic (NorFor; Volden, 2011) and the Dutch (DVE/OEB; van Duinkerken *et al.*, 2011) protein evaluation systems with lower efficiencies for proteins than for carbohydrates. The DVE/OEB2010 system (van Duinkerken *et al.*, 2011) is based on the yield of ATP from fermented substrates into VFA, with 27.3 mmol/g polysaccharides (structural polysaccharides, starch), 23.9 mmol/g mono-, di- and oligosaccharides, and only 13.7 mmol/g CP. These nutrient-specific efficiencies could also have affected differences between *in situ* and *in vitro* results in our study.

Therefore, based on the assumption, that the efficiency is twice as high in CP-free FOM than in degraded CP, prCP<sub>8</sub> in situ was recalculated assuming an efficiency of MCP yield of 104 g/kg degraded CP and 208 g/kg CP-free FOM derived from the values 181 g MCP/kg FOM and 25.6% degraded CP in FOM (mean value of all samples in our study assumed to be near to that in the study of Lebzien and Voigt, 1999). The relationship between in vitro and in situ prCP8 values calculated assuming uniform efficiency (filled symbols) or substrate-specific efficiencies for degraded CP and FOM-CP free (clear symbols), respectively, is given in Figure 3-1. This differentiation notably affected prCPs in situ values of solvent-extracted oilseed meals (sunflower meal, soybean meal, rapeseed meal), since about 40 to 50% of their total FOM composed of fermented CP, approaching the respective values to those obtained in vitro. Consequently, assuming a substrate-specific efficiency improved the relationship between both methods ( $R^2 = 0.79$ , RMSE = 21.3 vs.  $R^2 = 0.76$ , RMSE = 24.7). Although, this recalculation does not yet provide the true values for prCP<sub>8</sub> in situ, it obviously indicated the insufficient assumption of a constant efficiency for MCP synthesis in situ and the possible improvement trough the in vitro estimate. Additionally, slightly higher values of prCP<sub>8</sub> in vitro for measured feed mixtures than for calculated feed mixtures indicated positive associative effects, which were less pronounced in situ. This in turn would suggest a variable yield of MCP depending on the composition of the FOM, further highlighted by generally lower prCPs in situ compared to prCP<sub>8</sub> in vitro. The modHGT might therefore be more sensitive to reflect differences in the efficiency of microbial CP yield.

Using FOM determined in situ to calculate prCP in situ considers the ruminal degradation of OM depending on the passage rate (Krieg et al., 2018), however, a uniform passage through the rumen of all OM components cannot be assumed. Rather, fractional passage rates are discussed, which determine both the extent of degradation of the respective substrate and the efficiency of MCP yield (Sauvant and Nozière, 2016). Fractional passage rates largely depends on DM intake (NRC, 2001; Sauvant and Nozière, 2016) and are further differentiated into liquid, concentrate and forage particles (INRA, 2018; Thomas, 2004; Volden, 2011) as well as nature of nutrients (CP, starch, NDF, non starch polysaccharides; van Duinkerken et al., 2011). For the methods used in this study a uniform retention time, which corresponds to a uniform passage rate, is realized, since samples retain in polyester bags (in situ) and syringes (in vitro) without any outflow. On the other hand, small particles and the soluble fraction can escape from polyester bags without being fermented (Ahvenjärvi et al., 2018), which may lead to an underestimation of RUCP, especially in samples with a higher proportion of soluble CP. In the modHGT system removal of the fermentation products cannot occur, which seems to be a disadvantage of this method especially regarding MCP yield. Indeed, lysis of MCP might be higher in vitro than in the rumen in vivo, whereas calculated MCP from FOM in situ neglects any lysis or supposes lysis identical to the study of Lebzien and Voigt (1999). Therefore, prCP in vitro limited to incubation times of 8 and 24 h without consideration of 48 h measurements seems to be necessary to avoid an extensive lysis of MCP already synthesized.

#### **Conclusions**

This study shows that both methods provide realistic estimates of the protein value of feeds, when assuming passage rates of 0.05/h and 0.08/h. Despite of their completely different approach a notable accordance between *in situ* and *in vitro* determined prCP values exists. Minor associative effects occur for *in situ* and *in vitro* determined prCP which were more pronounced by the modHGT indicating a higher sensitivity to reflect associative effects, but they were not of practical relevance in both cases. The modHGT can be seen as a sound alternative approach to *in situ*, while reducing effort and providing a routine method. Further studies are needed to validate and to calibrate *in vitro* data with *in vivo* observations.

## **CHAPTER 4**

### General discussion

# 4.1 Methods for evaluating the protein value of diets for ruminants

This chapter does not aim to give a comprehensive overview of all methods used for the estimation of protein value of ruminant feeds, which have been refined continuously, but still having different types of methodological limitations (Gidlund *et al.*, 2018). The presentation of different protein evaluation systems and their comparison will also not be addressed here. Rather, the focus is on a discussion of some basic methods available for analysing feed protein value to show the suitability of different methods for mapping prCP.

# 4.1.1 In vivo techniques

*In vivo* techniques serve as references in protein evaluation and are used to validate other methodological approaches, as they provide results received at physiological conditions and thus represents the "true" protein value most accurately. Measurements basically required are intake and excretion (urine, faecal) of nitrogen (N), duodenal flow and proportion of non-ammonia nitrogen (non-NH3-N) from microbial origin in the duodenal chyme. For this, surgical prepared animals fitted with abomasal or duodenal cannulas are needed, where flow samples can be obtained either through total collection or spot sampling (Rohr et al., 1984). Estimation of digesta flow and microbial crude protein (MCP) necessitates the application of reliable marker substances, often used are chromium oxide or the isotope <sup>15</sup>N, respectively (van Soest, 1994; Zhao and Cao, 2004). Alternatively, rumen outflow can be determined through the less invasive omasal sampling technique (Huhtanen et al., 1997), where samples are taken from omasum through rumen cannula. Advantageously, there is no contamination through abomasal secretions and studies of digesta flow are precise and demonstrates good repeatability, but efforts will not be lowered because the measurement requires the use of multiple markers (Ahvenjärvi et al., 2000; Broderick et al., 2010). In addition, omasal sampling technique is not prospected to be able to generate a sufficient dataset for calibration of less elaborate methods (Steingaß and Südekum, 2013). Due to the time-consuming, laborious, and expensive in vivo measurements (Hristov et al., 2019; Westreicher-Kristen et al., 2015), only small numbers of samples can be analysed. Hence, this technique is not suitable for routine application (Gidlund *et al.*, 2018). It should be taken into account that *in vivo*  values are also only estimates, whose underlying measured values are subject to numerous uncertainties, which can therefore lead to misjudgements of the protein value (Steingaß and Südekum, 2013). *In vivo* methods are limited in accuracy mainly due the reliability of the digesta markers and variation among animals (Stern *et al.*, 1997). For instance, the markers used must be non-absorbable (unless that's the purpose), closely associated with the material it is to mark, and must be homogeneously mixed with the digesta (Faichney, 2005). Furthermore, knowledge about the amount of endogenous N is needed (Flachowsky and Lebzien, 2006), commonly derived from a fixed value related to chyme DM flow.

To overcome the problems of animal welfare and limitations due to the use of markers, methods based on indicator substances were developed. These substances occur under natural conditions at least partly in animal excreta, thereby allowing for noninvasive sampling even under on-farm conditions (Dickhoefer et al., 2015). Degradation of nucleic acids or of adenine and guanine, respectively, forms purine derivates (PD; hypoxanthine, xanthine, uric acid, allantoin), which are predominantly excreted in urine. The urinary PD originate from absorbed purines of exogenous sources (feed, MCP) as well as endogenous contribution of PD from body tissue (Tas and Susenbeth, 2007). The proportion of nucleic acids absorbed from feed is variable but would not contribute significantly to PD excretion in urine (Kehraus et al., 2006), whereas the excretion of endogenous PD is described as a constant per kg metabolic body weight (Chen and Ørskov, 2003). Thus, PD excreted via urine in ruminants mainly originate from absorbed purines from microbial origin. Hence, microbial N flow to the duodenum can be estimated by quantifying urinary PD excretion (Tas and Susenbeth, 2007). First, duodenal absorption of purines from microbial origin is estimated from PD excretion in the urine considering endogenous contribution. Next, absorption of purines is used to calculate total duodenal microbial N flow taking account of the digestibility of microbial purines, the N content of purines and the ratio of purine-N to total-N in mixed rumen microbes (Chen and Ørskov, 2003). Besides being non-invasive and suitable to be applied in experimental studies, PD method is advantageous over the invasive in vivo methods as PD analysis in urine is rapid and cheap. However, using the urinary PD method, the following variables have to be assumed to be constant: the ratio of purine-N to total-N in microbial mass, the true intestinal digestibility of purine nucleosides, and recovery rate of absorbed exogenous purines in urine.

In contrast to the approaches described above, where MCP yield is estimated, the *in situ* technique is usually used to determine RUCP (Zhao and Cao, 2004). Although the *in situ* method is normally not counted as an *in vivo* method, it is also included

in this section, as the samples are incubated directly in the rumen by introducing feed samples placed in polyester bags into the ventral sack. After a certain incubation time, bags are removed, and the remaining nutrient mass is measured. An exponential model is applied to the data, which allows the calculation of effective degradability for different passage rates (Ørskov and McDonald, 1979). This procedure has been widely used and a huge data basis is available, because in situ RUCP values are part of feed evaluation systems for example in northern countries (Volden, 2011), the Netherlands (Tamminga et al., 2007; van Duinkerken et al., 2011), the United States (NRC, 2001), and also in Germany (GfE, 2001). However, several problems of the *in situ* technique regarding RUCP evaluation are still present (Broderick and Cochran, 2000; Michalet-Doreau and Ould-Bah, 1992) and the reproducibility was not satisfactory in interlaboratory tests mainly due to insufficient standardisation (i.a., grinding, drying, bag material, bag pore size, sample size to bag surface ratio, washing procedure) (Madsen and Hvelplund, 1994). Furthermore, a high sample throughput or routine application of the *in situ* method is not possible, which fortified the need to estimate protein values by laboratory methods (Böttger et al., 2019b).

## 4.1.2 In vitro techniques

To determine the protein value *in vitro* a variety of methods have been developed, but unfortunately there are only few comparisons with *in vivo* data (Hristov *et al.*, 2019). Generally, these *in vitro* methods are based on incubation of feed samples in a medium reflecting rumen condition. Most of these aim at measurement of CP degradation, whereas only a few methods can estimate MCP yield or the total amount of prCP. Furthermore, "it is important to point out that *in vitro* techniques may provide satisfactory accuracy for comparative purposes, but rarely absolute values that are comparable to *in vivo* data (Hristov *et al.*, 2019)".

#### 4.1.3 Rumen-fluid based in vitro methods

One of the pioneering work in rumen-fluid based methods was described by Tilley and Terry (1963) using rumen-fluid from cannulated sheep. This method based on two main stages starting with an incubation of a small feed sample in rumen-fluid buffer-solution under anaerobic conditions, followed by a second stage to remove insoluble protein (RUCP and MCP) through incubation in a pepsin-HCl-solution. The method was proposed to be suitable for routine evaluation of *in vitro* DM digestibility, due to simplicity, reproducibility, and the opportunity to evaluate many samples within a single experiment.

Czerkawski and Breckenridge (1977) developed a semi-continuous rumen simulation technique (RUSITEC) aiming to reproduce the physiological processes in the rumen as closely as possible. For this, feed samples enclosed in polyester bags are introduced in perforated fermenter vessels and incubated in fermentation chambers in a rumen-fluid buffer solution, while fermentation conditions (e.g., pH value, temperature, flow rate, feed quantity, feed composition) are maintained continuously, or adapted to research questions accordingly (Boguhn, 2004). This enables to preserve microbial population under 'natural conditions' over a longer period of time of up to 34 days in the study of Czerkawski and Breckenridge (1977). Basically, the feed residues in the bags, the liquid and gaseous overflow, and the fermenter liquid are available for sampling, which enables a variety of different analyses (e.g., degradation of crude nutrients and detergent fibres, liquid- associated microbes, microbial efficiency, methane production). Compared to closed in vitro methods one of the most important advantages of this system is the continuous removal of fermentation products, i.e. volatile fatty acids (VFA) and ammonia (NH3), which potentially inhibit fermentation in batch culture systems (Brandao et al., 2020). Much research has been done to further improve this system, but the representation of different passage rates between the liquid and solid phases as well as the absorption of degradation products by the rumen wall cannot yet be depicted with sufficient accuracy (Boguhn, 2004). The daily exchange of the bags needed leads to a brief entry of air into the system, which can have a negative effect on certain microorganisms. Further, a strikingly low OM or neutral-detergent fibre degradation of 44 and 47% in maize silage and grass silage, respectively, was recorded by Zuber (2017). Thus, microbial yield derived by RUSITEC studies might not be correctly estimated. The low standardization of the method regarding polyester bag pore sizes, feed particle lengths, or buffer infusion rates limits repeatability and reproducibility of the results. Due to the considerable time and personnel expenditure involved in maintaining the system, RUSTIEC cannot be seen as a suitable routine method and should therefore be regarded as a system for basic research and at best as a screening method.

Zhao and Lebzien (2000) developed a technique, which is based on the first stage of the two-stage technique according to Tilley and Terry (1963). Feed samples and blanks are incubated for 24 h in glass tubes containing a rumen-fluid buffer solution. Subsequently, the samples are filtered, and N is determined in both, the liquid, and the solid parts. Post-rumen CP is further calculated from N measurements of the samples and the residues corrected for the blanks (only rumen fluid buffer solution without substrate). *In vitro* prCP was significantly correlated to *in vivo* data (Lebzien

*et al.*, 1996; Zhao and Lebzien, 2000) and the incubation technique was slightly modified for the estimation of utilizable AA (Zhao and Lebzien, 2002).

Similarly, the Hohenheim gas test (HGT) as well as its extension (eHGT) or modification (modHGT), are based on incubation of feed samples in a rumen-fluid buffer solution, with minor differences between each approach in terms of incubation times and composition of the incubation medium. In contrast to the RUSITEC, these approaches are static systems, which neither allow nutrient supply nor removal of fermentation products. The HGT (Menke and Steingaß, 1988) acts as a standard method in Germany to estimate DOM and ME in ruminant feeds, for which gas production (**GP**) after 24 h of incubation and chemical composition of the feeds are used (GfE, 2001). The eHGT (Raab et al., 1983) is based on an incubation of the feed samples with and without addition of carbohydrate mixture and the subsequent recording of GP and NH3-N content (steam distillation) in the liquid of the incubated feed sample and the respective blanks. In vitro degradable N is estimated through linear regression between NH<sub>3</sub>-N and GP. The theoretical point of zero GP (intercept) represents the amount of NH3-N, which would be released due to CP degradation only, as no energy is available for MCP synthesis. *In vitro* degradable N is thus calculated by the difference between the intercept of the regression and NH<sub>3</sub>-N of the blank samples related to the total N in the incubated feedstuff (Raab et al., 1983). This method is also described in detail by Wild et al. (2019) and Böttger et al. (2019b) and a modification was published by Karlsson et al. (2009). This modification included some methodological changes like sampling at different times from the same flask, as well as a pre-incubation of the rumen-fluid with carbohydrates to increase the microbial activity on the one hand and to reduce NH<sub>3</sub>-N background values on the other hand. By allowing samples to be taken from the liquid phase within the same flask during incubation, the method is more practical and consistent than the use of glass syringes within the eHGT (Karlsson et al., 2009). In addition, higher sampling frequency opens the possibility to estimate kinetic parameters of CP degradation. But comparison to in situ data seemed to be problematic and ranking of the feed samples differed between in situ and in vitro estimated effective protein degradation in the study Karlsson et al. (2009), where the loss of SP out of the bag and escape of soluble N from rumen degradation was mentioned as most probable reasons. The buffer solution used for incubation of feeds in the modHGT (Steingaß et al., 2001; Steingaß and Südekum, 2013) contains additional N compared to the HGT to ensure unlimited microbial fermentation. In contrast to the method of Zhao and Lebzien (2000) where prCP is determined as precipitant in the incubation residue, the modHGT estimates the prCP as the difference between NH<sub>3</sub>-

N of the incubated sample and total N of the *in vitro* batch (Westreicher-Kristen *et al.*, 2015). Principals have been described in detail e.g. by Edmunds *et al.*(2012a), Böttger and Südekum (2017a, 2017b) and in our studies (**Chapter 2, Chapter 3**) This method also shows potential to represent effective prCP for a certain passage rate providing suitable protein values at different feeding levels (Südekum and Böttger, 2019; Westreicher-Kristen *et al.*, 2015). Gidlund *et al.* (2018) studied the relationship between *in vitro* determined prCP and omasal flow of CP in lactating dairy cows and found a close relationship ( $\mathbb{R}^2 = 0.87$ ) between the data.

*In vitro* methods for determination of prCP are suitable for routine analysis, because they are fast, simple, and of low costs (with exception for the cost of keeping fistulated animals) (Zhao and Cao, 2004).

## 4.1.4 In vitro methods without rumen-fluid

The suitability of *in vitro* methods described above is limited by the need of rumencannulated animals, which may not be available in all laboratories. Alternatively, animal-independent methods are required (Westreicher-Kristen *et al.*, 2015). Such methods can provide information about CP degradation and could therefore be an alternative to the *in situ* method. However, they are not able to give any information about MCP yield.

The simulation of feed CP degradation by the use of enzymes commercially available aims for results similar to those found in vivo (Broderick and Cochran, 2000). Basically, the pure protein content of the feed sample is first determined by protein precipitation and true protein remaining in an enzymatic solution is used to estimate CP degradation (Steingaß and Südekum, 2013). In a review, Stern et al. (1997) illustrated the use of various proteases of bacterial (Streptomyces griseus), plant (papain, ficin, bromelain) or fungal (Aspergillus oryzae) origin in their ability to predict ruminal CP degradation compared to in situ measurements. Herein, some aspects affecting the results exist, such as enzyme concentration, enzymatic activity, pH value, and the presence of reducing factors or starch. One year later, Licitra et al. (1998) published a standardized regulation using a Streptomyces griseus protease. In addition, an extensive study was conducted by Gallo et al. (2018) to identify a suitable combination of enzyme concentration and incubation time. By now, many studies conducted using Streptomyces griseus have been published, also recently (Bachmann et al., 2020b; Bachmann et al., 2020a; Böttger et al., 2019a), but the main criticism of enzymatic approaches is that the rumen spectrum of proteolytic activity cannot be represented with enough precision (Hristov et al., 2019). However, the great advantage of this procedure is, that it can be easily standardised, and a high sample throughput can be implemented with good repeatability and reproducibility. Thus results may be sufficiently accurate for comparative purposes and to evaluate treatment effects on RUCP (Hristov *et al.*, 2019).

The CP fractionation (Licitra et al., 1996) is based on an analytical determination of CP, soluble CP (SCP), neutral detergent insoluble CP (NDICP), and acid detergent insoluble CP (ADICP) of feeds. Subsequently, multiple linear regressions are used to derive an overall RUCP value for the total CP in the feed (Kirchhof et al., 2010; Kirchhof, 2007; Shannak et al., 2000). From the analytical fractions (CP, SCP, ADICP, NDICP), five subfractions of CP are estimated related to the rate of rumen degradation in the American Cornell Net Carbohydrate and Protein System (CNCPS; Sniffen et al., 1992): NPN (A), rapidly (B1), moderately (B2) and slowly degradable (B3) true protein, and CP bound to ADF considered neither as rumen degradable nor digestible in the intestine (C). By contrast to the method of CP fractionation, an undegraded fraction is assigned to each individual CP fraction in the CNCPS system (Sniffen et al., 1992). Prediction of in situ RUCP from chemical fractionation of feed CP according to CNCPS was proven for concentrates (Shannak et al., 2000), dried distillers grains with solubles (DDGS) (Westreicher-Kristen et al., 2012) and forages (Kirchhof et al., 2010). However, Böttger et al. (2019b) point out the importance of the quality of the prediction equations and the need for feed-specific equations, as differences can also occur within different types of feedstuff. The equations proposed by Shannak et al. (2000) were validated for concentrates, but are unsuitable for roughages (Edmunds et al., 2012b; Kirchhof et al., 2010; Kirchhof, 2007), for DDGS (Westreicher-Kristen et al., 2012), or rapeseed meal (Böttger et al., 2019b). In a comparison of RUCP estimates by laboratory methods, CP fractionation yielded generally higher values compared to an enzymatic approach (Streptomyces griseus) or eHGT, which were partly higher than the theoretical maximum (Böttger et al., 2019b). However, besides differed absolute RUCP values (g/kg CP) the ranking of the samples was comparable among methods (Böttger et al., 2019b). Zhao and Cao (2004) found a significant multiple regression relationship ( $R^2 = 0.90$ ; P < 0.0001) between in vitro prCP (determined according to Zhao and Lebzien, 2000) and CNCPS CP fractions in feeds and suggested their use as a possible alternative to estimate prCP of ruminant feeds, if donor animals are not available. Chemical analysis were more complicated than rumen-fluid based in vitro techniques, but could be easily performed in most laboratories (Zhao and Cao, 2004).

# 4.2 Detailed comparison of the in situ method and the modHFT

This chapter focusses on a detailed discussion and comparison of the *in situ* and *in vitro* method – applicated within the present thesis– with respect to their suitability for prCP estimation.

#### 4.2.1 In situ method

The protein value of ruminant feeds is usually assessed through the application of different protein evaluation systems. Comparability of the literature data is hampered by the fact that systems consider different influencing factors and are based on various assumptions. In particular, this refers to the estimation of MCP yield. However, there is broad agreement between different systems on the use of RUCP values derived from in situ measurements (GfE, 2001; NRC, 2001; Thomas, 2004; van Duinkerken et al., 2011). Due to the widespread use, these values can act as a guide, but they could not be seen as an absolute reference, because many factors influence the accuracy of the measurement of *in situ* degradation. Some of them are listed by the work of Lebzien and Flachowsky (2005) such as a uniform grinding of the feedstuffs and the resulting change in degradability compared to the original material, an unrepresentative microbial activity within the bags compared to the activity in the rumen (Huhtanen et al., 1998), small particles and water-soluble fraction escaping ruminal fermentation (Hvelplund and Weisbjerg, 2000), or microbial contamination of the bag residues (Krawielitzki et al., 2006). The last two aspects are frequently mentioned and important for the present work. Both will be briefly addressed in the following.

With the *in situ* method, degradation of feed components is estimated through incubation of feeds placed in polyester bags in the rumen of cannulated animals for various length of time. Herein it is assumed, that each component can be separated into a non-washout and a washout fraction, whereas non-washout fraction consists of potentially degradable and non-degradable parts. Washout fraction includes the components that have leaked from the bags due to water solubility (**WS**) or small particle (**SP**) size (Tamminga *et al.*, 2007). Commonly, degradation profile of feeds is described by first-order kinetics model according to Ørskov and McDonald (1979) or the model including the lag phase (McDonald, 1981). In these equations, washout fraction is regarded as soluble and immediately degraded which, however, is not correct. So, Hvelplund and Weisbjerg (2000) proposed to correct degradation data for SP losses, by transferring the degradation kinetics from samples incubated in the bags to SP, which was realized in the present studies accordingly. However, SP

and WS have the potential to escape the rumen undegraded via the liquid phase (Ahvenjärvi *et al.*, 2018; Volden and Larsen, 2011). In this context, Ahvenjärvi *et al.* (2018) reported a 12.5% escape of soluble non-NH<sub>3</sub>-N (free AA, peptides, and soluble proteins) in grass silages. Consequently, RUCP content may be underestimated by 11-12 g RUCP/kg CP for grass silages evaluated in **Chapter 2** containing about 60-65% soluble CP (in CP; *in situ* fraction *a*). However, NH<sub>3</sub>-N content of the grass silages after freeze-drying was unknown and it cannot be assumed that *in situ* fraction *a* of the grass silages was entirely composed of non-NH<sub>3</sub>-N. The volatility of NH<sub>3</sub>-N during the drying process depends on the pH value and is reported to be 32% for silages with a pH value between 4-4.5 (Weißbach and Kuhla, 1995), which applies to about two thirds of the silages evaluated in our study. On the other hand, NH<sub>3</sub>-N content of the silages was about 11 g/kg CP, corresponding to only about 2% of the soluble fraction. Thus, the actual absolute value of escape fraction cannot be given at this point, the figures only intended to show the meaning of the escape of soluble N compounds.

The principle of the *in situ* method is that microorganisms entering the porous bags and subsequently colonize the feed samples for its degradation in a similar way than in the rumen (Hvelplund and Weisbjerg, 2000). Washing procedure after incubation aims at removing rumen content, degraded substrates, and microbes. However, some microbes will be still attached to feed residuals ('microbial contamination') and accounted as undegraded feed fraction (Hvelplund and Weisbjerg, 2000). Since microbial mass contains 512 g CP, 167 g EE, 51 g starch, and 270 g residual fraction (cell wall) per kg OM (Volden, 2011), microbial attachment can lead to an underestimation of ruminal CP degradation, in particular, whereas the effect on DM degradation will be of minor importance (Hvelplund and Weisbjerg, 2000). Krawielitzki et al. (2006) published an estimation formula to correct the residuals for microbial contamination. The variables Amax (maximum contamination) and R (rate of contamination) required for this can be calculated from CP and NDF content of the samples. This correction was applied to all samples of the present work. However, Edmunds *et al.* (2012b) showed that Amax of grass silages was overestimated through the equation proposed by Krawielitzki et al. (2006) by 75 (±31) mg microbial CP/g residue CP compared to an analytical measurement of Amax. A correction for microbial contamination may therefore be more accurately if Amax is determined analytically.

Several studies indicated, that the importance of RUCP is overrated (Beever and Cottrill, 1994; Ipharraguerre and Clark, 2005; Santos *et al.*, 1998). Consequently, a

precise determination of MCP would be of greater importance for the assessment of the protein value. To estimate MCP synthesis, information on the amount of FOM is needed, which provides the energy for microbial synthesis. A variety of equations exist, whereby FOM is estimated based on DOM, or other easily available parameters (Huhtanen, 2005). The main problem using DOM is that variable proportions of disappeared substances are fermented in the rumen (Huhtanen, 2005). Thus, in some protein evaluation systems, DOM is corrected for substances that provide little or no energy to the microbes such as EE, fermentation products (FP) in silages, RUCP or bypass starch (INRA, 2018; Tamminga et al., 1994). Others determine FOM by summation of rumen degraded fractions determined in situ (Thomas, 2004; Volden, 2011). Within the present work, it was assumed that FOM was precisely given by effective OM degradation determined in situ (EDOM), although part of the OM washout-fraction might also have escaped fermentation. Correction for substances that have leaked from the bag but do not provide energy may allow further improvement. This includes FP or EE, whose consideration may be particularly important if these ingredients are present in high amounts. Grass silages (Chapter 2) originating from the same material were used and tested for treatment effects of 'DM concentration before ensiling' and 'addition of lactic acid bacteria (LAB) inoculant'. Both treatments primarily affected fermentation pattern of the silages. In general, there was a more intensive fermentation in both, restrictively wilted and LAB treated silages, resulting in a higher content of FP compared to more intensively wilted and/or untreated silages. Thus, differences between the samples mainly occur through amount of FOM. Main contributors to FP are lactic acid (LA) and VFA, but depending on component and drying conditions variable amounts of FP are lost during the drying process (Tamminga et al., 2007). Porter and Murray (2001) described an almost complete evaporation of alcohols, whereas VFA evaporated to 55-90% and LA to 10-40%. In the DVE/OEB2007 system, 100%, 50% and 8% evaporation is assumed for alcohols, VFA and LA, respectively (Tamminga et al., 2007). In our study (Chapter 2) the evaporation of LA and of propane-1,2-diol was tested separately by adding the respective FP to grass hay and subsequent freezedrying. This resulted in a weight change of treated hay samples and showed that major amounts (>85%) of both substances were still present on the feed after the drying procedure. Therefore, FOM in grass silages was derived from EDOM corrected for the amount of LA and of propane-1,2-diol, as both being themselves the end products of microbial fermentation in the silo and were expected to provide no energy to rumen microbes. The inaccurate assumption of complete non-volatility of LA and of propane-1,2-diol was, in our opinion, justified by the fact that a small

proportion of the VFA might have still been present on the feed material, which was accounted as completely volatile.

Concentration of EE decreased with increased DM concentration in grass-clover silages evaluated by Johansen *et al.* (2017). The same effect was also seen for the grass silages evaluated in our study (**Chapter 2**). If additionally discounting EE from EDOM to calculate FOM, the positive effect of wilting on prCP might be slightly more pronounced. However, the change in EE might be related to oxidation of unsaturated fatty acids during wilting (Johansen *et al.*, 2017; van Ranst *et al.*, 2009) and occur due to analytical inaccuracy rather than an actual change in the amount of non-fermentable substances. Thus, no correction for EE was made within the present work. The FOM from feeds and feed mixtures (**Chapter 3**) was derived from EDOM without further discounts for FP und EE, because these differences were considered as marginal and should not have affected the ranking of the feeds.

It is conceivable that feeds/feed components are fermented at different rates and to different extents, which further complicates a precise estimation of FOM. According to the Dutch DVE/OEB2007 system (Tamminga et al., 2007), OM in ruminant feeds is separated into CP, starch, sugars (mono- and disaccharides), glucose oligosaccharides, EE, NDF, FP, and residual non-starch polysaccharides (pectins, arabans, xylans and beta-glucans). Theoretically, all these ingredients would have to be determined in the bags before and after incubation to give precise information about the extent of disappeared or fermented nutrients. Due to the enormous number of additional bags required, it is not possible to determine the degradation of individual ingredients. With two replicates per sample at each incubation time (about 7 time points) in each animal (minimum 3 animals) about 42 bags would be needed per additional nutrient fraction. However, Olaisen et al. (2003) have found that incubation times could be narrowed down further, as degradation was estimated with sufficient accuracy by two or three incubation times, reducing the number of polyester bags by 58 to 78% in their study. In addition, near-infrared spectroscopy offers the possibility to further limit the sample size (Krieg et al., 2018) or to keep it at the previous level. Total analysis of the ingredients using near-infrared spectroscopy is conceivable, but requires precise validation, which will also involve an enormous effort.

The most critical point in our *in situ* approach is not the estimation of FOM, but the calculated MCP therefrom. Data on the efficiency of MCP yield and its variation is available in the literature. For example, the NRC (2001) declares a variation of 12-45 g microbial N/kg FOM or 75-338 g MCP/kg FOM, respectively, within a summarised literature data set. In an early version of the Dutch DVE/OEB system a fixed amount

of 150 g MCP/ kg FOM was assumed (Tamminga et al., 1994) and the value of 181 g MCP/ kg FOM used in our studies is given with a range of 69-266 g/kg FOM (Lebzien and Voigt, 1999). Despite the wide variation in the efficiency of MCP yield, it is not so much the absolute value rather than the assumption of a constant value of MCP/kg FOM that is to be questioned. By assuming a constant value of MCP yield, in situ prCP content may decrease with an increase in passage rate (Krieg et al., 2018). However, this is not to be assumed, since in general, increasing passage rate has a positive effect on both RUCP content and MCP yield. Faster passage rates reduces CP degradation in the rumen on the one hand, and increases the efficiency of MCP yield on the other (Sauvant and Nozière, 2016). The increased MCP yield in turn is largely attributed to the reduction of energy demand for maintenance requirement of the microbes, and reduced lysis in the rumen of MCP already synthesised (Hackmann and Firkins, 2015). Although the measurement of FOM in situ considers the ruminal degradation of OM in relation to (uniform) passage rate (Krieg et al., 2018), the neglect of the fractional passage rate of liquid, solid, concentrate and forage fractions (Thomas, 2004) represents a further limitation of the *in situ* method. Moreover, fermented substances deliver variable amounts of energy for MCP synthesis. The yield of ATP from fermented substrates into VFA is 27.3 mmol/g polysaccharides (structural polysaccharides, starch), 23.9 mmol/g mono-, di- and oligosaccharides, and only 13.7 mmol/g CP (van Duinkerken et al., 2011). Although VFA do not yield ATP for microbial growth, LA is known to provide a small amount of energy for MCP synthesis of about 20% of those supplied from carbohydrates (Volden, 2011). Thus, the complete discount of the amount of LA from EDOM in grass silages (Chapter 2) could have provided slightly underestimated values of FOM. An even more accurate assessment of MCP synthesis would therefore be possible, if nutrient-specific efficiencies could be applied. An attempt was made in **Chapter 3** where a lower efficiency for rumen-degradable CP and a higher one for FOM-CP free was applied to estimate MCP yield. It was concluded that this could lead to a more accurate assessment of the prCP, especially for high-protein feeds.

Prospectively, it could be expected, that *in vivo* experiments (including *in situ* measurements) will no longer be carried out in Europe for animal welfare reasons and routine testing in animals is therefore not conceivable.

### 4.2.2 Modified Hohenheim gas test (modHGT)

The key problem with prCP determined by the *in situ* method is that on the one hand, RUCP measurement shows some inaccuracies, and on the other hand, that the estimation of MCP is subjected to various assumptions. Consequently, a simple

addition of both variables might lead to an accumulation of errors (Lebzien *et al.*, 1996). Some of the mentioned problems of the *in situ* approach as SP loss, escape of soluble N, or microbial contamination, are removed by an *in vitro* batch system, additionally microbial access to the feed is not limited through pore size of the polyester bags needed for *in situ* incubations (Gidlund *et al.*, 2018).

Recent studies (**Table 4-1**) have used the modHGT, which provides a direct estimate of combined RUCP and MCP to characterise prCP *in vitro* of various feeds. A few of these studies compared *in vitro* determined prCP to reference values calculated based on equations proposed by GfE (2001). Only Krieg *et al.* (2018) compared *in vitro* determined prCP to reference values calculated according to Lebzien and Voigt (1999) as done in our studies. Therefore, the comparability of the results concerning the relationship between *in vitro* and *in situ* data of the studies conducted within this work with those described in the literature may be limited. Irrespective of this, two general findings can be highlighted in a consistent manner: (1) closer relationships between *in vitro* prCP and reference¹ values at higher compared to lower passage rates and (2) higher values for prCP *in vitro* compared to reference values at high passage rates and *vice versa*.

Difficulties concerning the interpretation of modHGT measurements mainly arise, regarding the choice of an adequate incubation time or passage rate, respectively. In addition, as with the *in situ* approach, fractional passage rates cannot be considered which might influence the results (Edmunds et al., 2012a). However, the consistent findings of the studies about closer relationships between in vitro and reference values at higher compared to lower passage rates (Table 4-1) support the assumption of Westreicher-Kristen and Südekum (2018) about a more precise reflection of in vivo MCP synthesis at short incubation times (corresponding to passage rates at high feeding level). Closer relationships due to higher passage rates were found in feeds and feed mixtures composed thereof in our study (k = 0.05/h,  $R^2 =$ 0.68; k = 0.08/h,  $R^2 = 0.76$ ; Chapter 3), in feed mixtures based on maize silage, red clover silage, lupin seed, soybean meal, and wheat grain (Westreicher-Kristen and Südekum, 2018), in DDGS (Westreicher-Kristen et al., 2015), and in forages (Edmunds et al., 2012a). However, the relationship between in vitro and in situ prCP values was not improved from k = 0.04 ( $R^2 = 0.61$ ) to 0.06/h ( $R^2 = 0.54$ ) in grass silages (Chapter 2). Moreover, the modHGT yielded higher prCP values compared to

reference values (prCP reference minus prCP *in vitro*) at high passage rates and *vice versa* (**Table 4-1**) for forages (Edmunds *et al.*, 2012a), DDGS (Westreicher-Kristen *et al.*, 2015), and grains (Krieg *et al.*, 2018). Similar observations were made for grass silages (**Chapter 2**) and feed mixtures (**Chapter 3**) evaluated within our studies.

Although the relationships described in the literature "indicates that the modHGT displays accuracy in ranking feeds according to protein value (Edmunds et al., 2012a)", the authors classify the coefficient of determination as moderate for forages (Edmunds et al., 2012a) and DDGS (Westreicher-Kristen et al., 2015). This was attributed to both, possible limitations in determining the reference values with the GfE (2001) equation, and some characteristics of the modHGT which are supposed as limitations (Westreicher-Kristen et al., 2015). The authors point out that the only factor that changes in GfE equation, if different passage rates are applied, is effective RUCP. This value, in turn, is determined using the in situ method, which is subjected to a high level of variation (Chapter 4.2.1). Since CP fractions are not considered in the GfE equation, Westreicher-Kristen et al. (2015) concluded that reference values of prCP in DDGS may be underestimated, as differences between in vitro and reference values were significantly correlated to CP fraction A (CNCPS, Sniffen et al., 1992). Thus, a possible explanation for the differences between the methods could be the combined effect of enough available energy and a high amount of NPN (CP Fraction A) in DDGS promoting MCP growth and consequently leads to higher prCP in vitro compared to reference values calculated based on GfE (Westreicher-Kristen et al., 2015). In addition, it should be noted that the in vivo method used to derive the regression equations proposed by GfE (2001) is also subject of errors (Edmunds et al., 2012a). For these reasons, Edmunds et al. (2012a) concluded that a more accurate representation of prCP at the chosen passage rate is probably given by the modHGT compared to the GfE equation.

Limitations of the modHGT are related to the closed system where neither nutrient supply nor outflow of fermentation products and N recycling can be considered (Edmunds *et al.*, 2012a; Gidlund *et al.*, 2018; Westreicher-Kristen and Südekum, 2018). As a result, increased incubation time leads to decreased prCP due to progressive feed CP degradation and lysis of MCP already synthesized (Steingaß and Südekum, 2013; Walker *et al.*, 2005). Closer relationships between the methods at higher passage rates might therefore mainly be a result of neglectable lysis. Any effect of N recycling, however, would be minimal and of minor importance, as the system has been developed so that N is not a limiting factor (Edmunds *et al.*, 2012a).

Concerning the problematic assumption of a nutrient-unspecific MCP yield as well as the uncertainties in FOM estimation, the modHGT shows advantages over the *in* situ method. For example, Bakken et al. (2017) assessed the effect of wilting rate and the use of silage additives (formic acid, LAB) on in vitro protein value in silages from two cuts (first, second) with different proportions of grass or clover species. Differences in prCP due to herbage composition or wilting rate could not be detected within their study. This apparent insensitivity of the modHGT was attributed by the authors to possible factors limiting MCP synthesis, such as a lack of CP or energy in the silages of the first and second cut, respectively. The efficient use of CP for MCP synthesis due to enough available energy in the first cut and the surplus of CP in the second cut may have led to equal prCP in vitro in both (Bakken et al., 2017). Nevertheless, the modHGT revealed an effect of silage additive within the cuts with higher prCP values for restrictively fermented silages (formic acid) than intensively fermented silages (LAB). For grass silages examined in Chapter 2, no significant differences in prCP in vitro between the control group and the LAB treatment was found. Similarly, Bakken et al. (2017) did not find any significant differences between the control group and the LAB treatment, but only between LAB and FA. Restrictively fermented grass silages were ranked above intensively fermented silages in terms of prCP in vitro also in Chapter 2, but in this case the fermentation pattern was mainly determined by DM content of the samples, whereby DM content between samples did not differ in the study of Bakken et al. (2017). Restrictive fermentation due to formic acid treatment or higher DM content might lead to a more intensive MCP synthesis due to a higher amount of fermentable energy and a higher proportion of free AA and peptides in the NPN fraction (Dijkstra et al., 2013). If the amount of prCP<sub>4</sub> in vitro determined for grass silages (n = 16, Chapter 2) is regressed against the sum (g/kg OM) of LA and propane-1-diol, a negative relation was found  $(R^2 = 0.69)$ . This relation may help to reinforce the need to correct EDOM for these fermentation products to calculate FOM or MCP yield (Chapter 2), respectively, but there is not any correction needed using modHGT.

Moreover, both methods seem to be more reliable for the evaluation of mixed rations compared to individual components. On the one hand, GfE equations were based on *in vivo* experiments, which were carried out using mixed rations (Westreicher-Kristen and Südekum, 2018). On the other hand, the modHGT might deliver more reliable prCP values due to the consideration of possible interactions between feeds as well as various effects on MCP synthesis (Gidlund *et al.*, 2018). For instance, MCP synthesis may not be fully detected in protein feeds like soybean meal (**Chapter 3**) if incubated without other dietary components, because MCP growth may be

restricted due to excess of degradable CP relative to the supply of FOM (Vaga *et al.*, 2017).

Furthermore, the modHGT shows additional advantages like a high sample throughput and a comparatively low effort. It also offers the possibility to combine it with the original HGT to determine ME and DOM (Steingaß and Südekum, 2013) or extend it to determine both, RUCP and prCP within the same procedure (eHGT). Therefore, it can overcome few methodological imprecisions of modern protein evaluation systems (Gidlund et al., 2018) and shows great potential for routine application in the future. Moreover, associative effects were recorded using the modHGT in feed mixtures at k = 0.08/h (Chapter 3) accounts for 10.7 g prCP/kg OM (equals 7.6 g prCP/kg DM) which seems of minor relevance. However, assuming a dry matter intake of 22 kg/d it results in a potential difference of 167 g prCP/d which corresponds to the requirement for about 2 kg milk (GfE, 2001). It should be noted that our figure only corresponds to the average value from the comparison of 13 rations. It is quite conceivable that associative effects are more pronounced, if the 13 rations were evaluated on individual basis or if rations were composed using other feed combinations. The modHGT therefore shows the potential to illustrate associative effects in feed mixtures and may allow for a more precise formulation of diets and consequently help to reduced feed cost and diminish environmental pollution, whereby the latter issue will become increasingly important worldwide. Further technical development described by Karlsson et al. (2009) enables frequent sampling from the same incubation vessels can still improve the applicability of the in vitro method (Vaga et al., 2017). To ensure standardisation of the method, a prCP standard is often carried along and used to correct the measured prCP values. In our study, but also in the study of Westreicher-Kristen et al. (2015) these standards were included, but only served as an internal control. However, Westreicher-Kristen et al.(2015) emphasises that such a correction is useful to reduce variations between different laboratories. Edmunds et al. (2012a) suggests possible improvement by the use of a forage based prCP standard to correct forage prCP data rather than the actually used concentrate based prCP standard. Bakken et al. (2017) additionally suggests a preincubation of carbohydrates in the rumen-fluid as described by Lorenz et al. (2011) to normalise NH<sub>3</sub> concentration in the incubation medium.

Unquestionably, one of the main criticisms on rumen-fluid based *in vitro* methods is the need for donor animals. It can be assumed that there will be further restrictions in the use of experimental animals, so research should focus on the development of an alternative to rumen-fluid inoculum. Literature described the

possibility of the use of fresh as well as frozen and thawed rumen-fluid from slaughtered animals to predict *in vitro* degradation of feeds (Chaudhry and Mohamed, 2012). Furthermore, the potential use of faecal inoculum for the *in vitro* gas production technique (Aiple *et al.*, 1992; Hughes *et al.*, 2012; Zicarelli *et al.*, 2011) and *in vitro* estimation of prCP (Zhao and Chen, 2004) was studied. Whatever future methods will look like, biological approaches will be necessary, because MCP synthesis cannot be achieved by purely chemical methods.

## 4.2.3 Consistency of methods

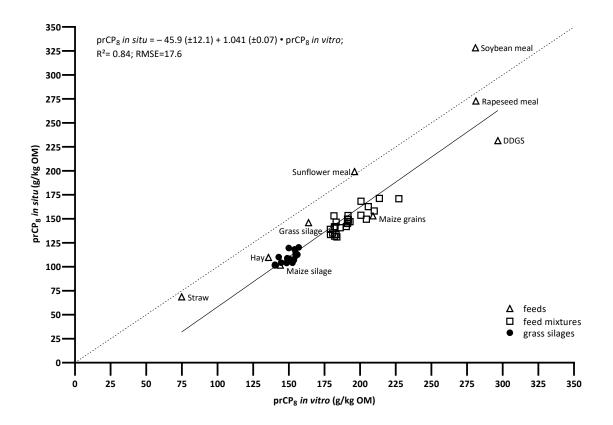


Figure 4-1: Relationship between *in vitro* and *in situ* determined post-rumen CP (prCP) of feeds  $[\Delta]$ , feed mixtures  $[\Box]$  and grass silages  $[\bullet]$  at passage rate of k = 0.08/h. Data was adapted from **Chapter 3** and **Chapter 2**, respectively. The dotted line represents the angle bisector.

In order to demonstrate the suitability of the modHGT and its wide range of application,  $in \, situ$  values of the feeds and diets presented in **Chapter 2** and **Chapter 3** were regressed against the respective  $in \, vitro$  values (**Figure 4-1**). To ensure a uniform presentation, values of the silage samples were plotted at an assumed passage rate of 0.08/h, although data was presented only at k = 0.02, 0.04 and 0.06/h in **Chapter 2**. Besides being rather unusual to calculate effective prCP from k = 0.08/h in forages, it was considered adequate for comparing both methods for demonstration purposes. No further adjustment of the data was made. Accordingly, the presented  $in \, situ \, data$  of the grass silages (**Chapter 2**) and of the feeds and mixed feeds (**Chapter 3**) were calculated from FOM derived from EDOM corrected for the proportion of FP (LA and propane-1,2-diol) or assuming a substrate-specific yield of MCP from degraded CP (104 g MCP/kg) and FOM-CP free (208 g MCP/kg), respectively. Further, data of effective prCP  $in \, vitro \, were \, derived \, from \, the incubation times of 8 and 48 h for grass silages ($ **Chapter 2**) or 8 and 24 h for feeds and feed mixtures (**Chapter 3**).

To simplify readability, the relationships described in the following have been numbered (No. 1-3) and listed in **Table 4-2**. Compared to the relation between *in situ* and *in vitro* values described for feeds and feed mixtures in **Chapter 3** (**Figure 3-1**) – again listed in **Table 4-2** (No. 1) – the inclusion of silage samples (No. 2) reduced standard error of the slope (not significant different from 1) and intercept as well as RSME, while improved  $R^2$ . The mean difference between absolute *in situ* and *in vitro* values of all samples was -39 ( $\pm 17.5$ ) g prCP<sub>8</sub>/kg OM.

The graph shows a consistent assessment for roughage and feed mixtures i.e., the relation between both methods do not apply exclusively to a specific feed group. However, the agreement was less in some feeds of extreme nutrient composition, such as straw or soybean meal. No statement can be made which method provides the biologically more correct value. If soybean meal and straw were removed before analysis (**Table 4-2**; No. 3), regression equation remained similar, but standard error of the slope and intercept was smaller and RMSE was reduced to 11.5.

The main problem of all *in vitro* methods is the lack of a reliable reference. But even if in vivo measurements in duodenal/abomasal cannulated animals are seen as the 'gold standard' (Edmunds et al., 2012a), they have some inaccuracies as described here. Therefore, the question about which method reflects the biologically 'true protein value' best, remains still open to discussion. For these reasons, the modHGT should not be misjudged as a possible method in feed evaluation (Westreicher-Kristen et al., 2015). The underlying data confirms the conclusions of previous studies regarding a reliable estimation of the prCP content by means of the modHGT, in particular for short incubation times reflecting passage rates at high feeding levels. The ultimate method to define the protein value of a diet or to show possible changes trough diets and feed treatments is a production trial (Huhtanen and Broderick, 2016). However, production parameters have not been used to validate protein evaluation systems till now, although such data can be measured more precisely than in vivo protein degradation and MCP yield (Huhtanen, 2005). Before routine use in practice, further standardization is needed and interlaboratory tests are required. It might be helpful to perform a limited number of *in vivo* trials covering the range of commonly used diets for calibration of the *in vitro* values, to allow those to be used in diet formulation and for the calculation of the protein supply to the animals. On a small number of production trials, in vitro methods should be calibrated to achieve a relative scale of absolute values.

## Summary

An important goal in dairy cattle feeding is to reduce nutrient excretion for ecological as well as economic reasons. In addition to knowledge of the animals' energy and protein requirements, precise information on the energy and protein values of the feedstuffs used is needed, to ensure adequate feeding of high-yielding dairy cows while minimising nutrient excretion. In the current German protein evaluation system, protein requirement of the animals and protein value of the feedstuffs are characterised by the amount of utilisable crude protein at the duodenum (uCP), which corresponds to the sum of rumen-undegraded crude protein (RUCP), and microbial crude protein (MCP) synthesised in the rumen. The term post-rumen crude protein (prCP) is used instead of uCP in the following and throughout this work. Considering the amino acid concentration and its intestinal digestibility, prCP can be converted into the internationally more common value metabolisable protein (MP).

Ruminal CP degradation, or RUCP content, respectively, is often determined using the *in situ* method, which can be regarded as a reference method due to its wide application. Animal-independent alternatives to determine CP degradation are given by enzymatic and chemical approaches. In contrast, a measurement of MCP yield can only be realised with considerable experimental effort in duodenally fistulated animals. Since MCP synthesis is primarily an energy-dependent process, MCP yield is derived from variables representing the amount of fermentable organic matter (**FOM**) in the rumen. However, the extent of MCP yield depends not only on the amount of FOM, but among other factors, on its nutrient composition, rumen available N sources and dry matter intake of the animal.

A promising *in vitro* method for measuring the content of prCP - the modified Hohenheim gas test (**modHGT**) - was evaluated in this work on the basis of two studies with regards to its suitability for determining the protein value. This method is based on incubation of feed samples in a rumen-fluid buffer solution and is sensitive to influences on MCP yield. To assess the modHGT method, prCP values determined *in vitro* and *in situ* were compared assuming different passages of the feed from the rumen to the small intestine (effective prCP). *In situ* prCP values were calculated from the sum of RUCP and MCP, assuming a formation of 181 g MCP/kg

FOM. The FOM was in turn derived from effective OM degradation determined *in situ*.

In addition to the method comparison, in the first study, the effects of wilting grass before ensiling, as well as the use of lactic acid bacteria (LAB) on the protein value of grass silage were tested *in vitro* and *in situ*. The sample material comprised a total of 16 grass silages, which differed in dry matter content before ensiling (170, 310, 390, 420, 470, 530, 580, 600 g/kg) and by addition of LAB (with, without). Both treatments primarily influenced the fermentation pattern of the silages. Compared to restrictively wilted or LAB treated grass silages, intensively wilted or untreated grass silages showed a lower fermentation acid concentration and a higher concentration of water-soluble carbohydrates, and vice versa. The results of the in situ and in vitro approach showed a positive linear effect of dry matter concentration on prCP content. The application of LAB increased RUCP, but decreased the calculated MCP, resulting in a lower in situ prCP content compared to untreated silages. In vitro, no effect of LAB treatment could be shown, indicating a complete compensation between increased RUCP content and decreased MCP yield. The in vitro method probably reacted more sensitively to treatment differences that primarily influence MCP yield, which could not be represented with sufficient accuracy due to the non-specific calculation of MCP in situ. Since all samples were prepared from the same material, effective prCP contents differed between the different grass silages only in a range of approx. 15-30 g/kg OM. Nevertheless, significant relationships between *in situ* and *in vitro* determined effective prCP values could be shown at all passage rates (0.02, 0.04, 0.06/h), which confirms the suitability of the modHGT for prCP analysis.

In the second study, a total of 9 feeds, 13 feed mixtures made thereof, and 12 feed mixtures provided by commercial dairy farms were examined. The feeds used in this trial covered a wide range of different chemical ingredients and were therefore suitable for a method comparison. Significant relationships between the effective prCP values determined *in situ* and *in vitro* could be shown at a passage rate of 0.05/h ( $R^2 = 0.68$ ) and 0.08/h ( $R^2 = 0.76$ ). The already problematic assumption of a constant efficiency of MCP yield of 181 g/kg FOM appeared to be insufficient for the underlying data set, as it could be assumed that the composition of FOM differed significantly between feeds. Subdividing FOM into fermented CP and FOM-CP free and subsequent recalculation of MCP (or prCP) assuming an efficiency of 104 g MCP/kg fermented CP and 208 g MCP/kg FOM-CP free, respectively, improved the relationship between both methods ( $R^2 = 0.79$ ).

Despite the completely different methodological approach, the results of both studies showed a notable agreement between prCP values determined *in situ* and *in vitro*. The results suggested a more precise estimation of prCP values by the modHGT compared to the *in situ* method and indicated a sensitive reaction of the modHGT with regard to changes in MCP yield.

## Zusammenfassung

Ein wichtiges Ziel in der Milchviehfütterung ist es, Nährstoffausscheidungen aus ökologischen, aber auch aus ökonomischen Aspekten zu reduzieren. Um eine adäquate Fütterung hochleistender Milchkühe bei Minimierung der Nährstoffausscheidung zu gewährleisten sind, neben der Kenntnis des Energie- und Proteinbedarfs der Tiere, präzise Angaben zum Energie- und Proteinlieferungsvermögen der eingesetzten Futtermittel erforderlich. Der Proteinbedarf der Tiere, sowie das Proteinlieferungsvermögen der Futtermittel werden im aktuellen deutschen Proteinbewertungssystem durch die Größe nutzbares Rohprotein am Duodenum (nXP) charakterisiert, welche der Summe aus pansenstabilem Rohprotein (UDXP) und im Pansen mikrobiell synthetisiertem Rohprotein (MXP) entspricht. Unter Berücksichtigung der Aminosäurenkonzentration und dessen intestinaler Verdaulichkeit kann das nXP in die international gebräuchlichere Kenngröße metabolisierbares Protein (MP) umgerechnet werden.

Ein anerkanntes Verfahren zur Bestimmung des Proteinabbaus im Pansen, respektive des UDXP, ist die *in situ-*Methode, welche aufgrund ihrer verbreiteten Anwendung als Referenz angesehen werden kann. Tierunabhängige Alternativen zur UDXP-Bestimmung bieten enzymatische und chemische Verfahren. Eine Messung des MXP hingegen kann nur unter erheblichem experimentellem Aufwand an duodenal fistulierten Tieren realisiert werden. Da die MXP-Bildung vor allem ein energieabhängiger Prozess ist, wird diese Größe daher von Variablen abgeleitet, welche die Menge an fermentierbarer organischer Masse (**FOM**) im Pansen repräsentieren. Der Umfang der MXP-Bildung hängt jedoch nicht nur von der Menge an FOM ab, sondern unter anderem auch von dessen Nährstoffzusammensetzung, der im Pansen zur Verfügung stehenden N-Quellen und der Trockenmasseaufnahme.

Eine vielversprechende *in vitro*-Methode zur Messung es Gehalts an nXP – der modifizierte Hohenheimer Futterwerttest (**modHGT**) – wurde im Rahmen dieser Arbeit anhand von zwei Studien hinsichtlich seiner Eignung zur Bestimmung des Proteinwerts geprüft. Diese Methode basiert auf einer Inkubation von Futtermittelproben in einer Pansensaft-Pufferlösung und reagiert empfindlich gegenüber Einflüssen auf die MXP-Bildung. Zur Beurteilung des modHGT erfolgte eine Gegenüberstellung von *in vitro* und *in situ* ermittelten nXP-Gehalten bei Annahme unterschiedlicher Passageraten des Futters vom Pansen in den Dünndarm (**effektives nXP**). Der *in situ* nXP-Wert wurde anhand der Summe von RUCP und MCP kalkuliert, wobei

eine Bildung von 181 g MXP/kg FOM unterstellt wurde. Die FOM wurde wiederum aus dem *in situ* ermittelten effektiven OM-Abbau abgeleitet.

In der ersten Studie wurde neben dem Methodenvergleich der Effekt des Anwelkens von Gras vor der Silierung, sowie der Einsatz von Milchsäurebakterien (MSB) auf den Proteinwert von Grassilage in vitro und in situ untersucht. Das Probenmaterial umfasste insgesamt 16 Grassilagen, die sich durch den Trockenmassegehalt vor der Silierung (170, 310, 390, 420, 470, 530, 580, 600 g/kg) sowie den Zusatz von MSB (mit, ohne) unterschieden. Beide Behandlungen beeinflussten in erster Linie das Fermentationsmuster der Silagen. Im Vergleich zu restriktiv angewelkten bzw. mit MSB versetzten Grassilagen, wiesen intensiv angewelkte bzw. unbehandelte Grassilagen eine geringere Gärsäurekonzentration und eine höhere Konzentration an wasserlöslichen Kohlenhydraten auf, und umgekehrt. Die Ergebnisse des in situ und in vitro Ansatzes zeigten einen positiven linearen Effekt der Trockenmassekonzentration auf den nXP-Gehalt. Der Einsatz von MSB führte zu einer Erhöhung des UDXP, verringerte jedoch das kalkulierte MXP und bedingte dadurch einen geringeren in situ nXP-Gehalt gegenüber unbehandelten Silagen. In vitro konnte kein Effekte der MSB-Behandlung gezeigt werden, was auf eine vollständige Kompensation zwischen erhöhtem UDXP und verringerter MXP-Bildung hinweist. Die in vitro Methode reagierte vermutlich sensitiver auf die Behandlungsunterschiede, die in erster Linie die MXP-Bildung beeinflussen, welche aufgrund der unspezifischen Kalkulation des MXP *in situ* nicht ausreichend genau dargestellt werden konnten. Da alle Proben aus demselben Ausgangsmaterial hergestellt wurden, unterschieden sich die effektiven nXP Gehalte zwischen den verschiedenen Grassilagen lediglich in einem Bereich von ca. 15-30 g/kg OM. Dennoch konnte zu allen unterstellten Passageraten (0.02, 0.04, 0.06/h) signifikante Beziehungen zwischen den in situ und in vitro bestimmten nXP-Werten aufgezeigt werden, was die Eignung des modHGT zur nXP Analyse bekräftigt.

Bei der zweiten Studie standen insgesamt 9 Einzelfuttermittel, 13 daraus hergestellte Rationen, sowie 12 von landwirtschaftlichen Betrieben bereitgestellte Rationen zur Verfügung. Die in diesem Versuch verwendeten Futtermittel deckten eine breite Variation verschiedener Inhaltssoffe ab und waren daher für einen Methodenvergleich geeignet. Signifikante Beziehungen zwischen den *in situ* und *in vitro* bestimmten nXP-Werten konnten sowohl bei einer Passagerate von 0.05/h ( $R^2 = 0.68$ ), als auch bei 0.08/h ( $R^2 = 0.76$ ) aufgezeigt werden. Die ohnehin problematische Unterstellung einer konstanten Effizienz der MXP Synthese von 181 g/kg FOM erschien für den zugrundliegenden Datensatz als unzureichend, da davon

auszugehen war, dass sich die Zusammensetzung FOM deutlich zwischen den Futtermitteln unterschied. Eine Unterteilung der FOM in fermentiertes XP und FOM-XP-frei und die anschließende Neuberechnung des MXP (bzw. nXP) unter der Annahme einer Effizienz von 104 g MXP/kg fermentiertes XP bzw. 208 g MXP/kg FOM-XP frei, verbesserte die Beziehung zwischen den beiden Methoden (R² = 0.79).

Trotz des völlig unterschiedlichen Methodenansatzes haben die Ergebnisse beider Studien eine auffallend gute Übereinstimmung zwischen den *in situ* und *in vitro* ermittelten nXP-Gehalten gezeigt. Die Ergebnisse deuten eine im Vergleich zur *in situ*-Methode präzisere Einschätzung des nXP-Gehalts durch den modHGT an und weisen auf eine sensitive Reaktion des modHGT hinsichtlich Veränderungen der MXP-Bildung hin.
